## RESOLUTION AUTHORIZING A TRANSFER OF \$30,000 TO KTOP FROM THE EMERGENCY CONTINGENCY ACCOUNT FOR CRITICAL EQUIPMENT NEEDS

**WHEREAS**, the City of Oakland is required by City Charter to provide televised legislative coverage to the citizens of Oakland; and

**WHEREAS,** KTOP, the official government access cable television station, was established to provide such coverage; and

**WHEREAS**, the equipment necessary to produce and distribute a live cable signal to the cable operator's headend from the Oakland City Hall has not been replaced and is past its useful life; and

**WHEREAS**, this equipment is no longer reliable in providing a live signal of legislative proceedings to cable subscribers, as required by local ordinance; now, therefore, be it

**RESOLVED:** That the Oakland City Council approve \$30,000 from the Emergency Contingency Fund for KTOP critical equipment repairs.
