A RESOLUTION AUTHORIZING THE CITY OF OAKLAND TO AMEND THE CONTRACT WITH THE UNITY COUNCIL TO INCREASE THE CONTRACT AMOUNT BY \$50,000 FOR A TOTAL OF \$100,000 FOR THE IMPLEMENTATION OF THE FRUITVALE MAIN STREET PROGRAM IN THE FRUITVALE DISTRICT .

WHEREAS, the Community and Economic Development Agency's Neighborhood Commercial Revitalization Unit has allocated \$50,000 from Community Development Block Grant Funds for commercial revitalization in the Fruitvale community; and

WHEREAS, the Community and Economic Development Agency's Neighborhood Commercial Revitalization Unit is the sponsoring agency and has been working in partnership with the Unity Council to develop and implement the Main Street approach in the Fruitvale commercial corridors; and

WHEREAS, funds have been allocated by the Local Initiative Support Corporation for the Neighborhood Main Street Initiative Program; and

WHEREAS, City staff has recommended a contract in an amount not to exceed \$50,000 with the Unity Council to implement the Fruitvale Main Street Program in the Fruitvale District; now, therefore, be it

RESOLVED: That the City Manager or his designee is authorized to amend the existing contract in an amount not to exceed \$50,000 with the Council to implement the Fruitvale Main Street Program in the Fruitvale District; and be it further

RESOLVED: That funds for said contract shall come from Community Development Block Grant funds allocated for commercial revitalization services in the Fruitvale commercial corridors; and be it further

RESOLVED: That City funding under the amended contract shall be conditioned on the commitment of at least \$100,000 in matching funds from other sources; and be it further

RESOLVED: That the City Council hereby authorizes the City Manager or his designee as agent of the City of Oakland to conduct negotiations, execute documents, and take any other actions with respect to the contract with the Council consistent with this Resolution and its basic purpose.
