At 3:07 p.m. a motion was made by Councilmember Kalb, seconded by Vice Mayor Kaplan to close the public hearing and approve the item on introduction and schedule for Final Passage on the December 20, 2022 City Council Agenda. The motion passed with a vote of 5 Ayes; 2 Excused: Bas, Fife; 1 Absent: Thao, with the following additional elements as direction to the City Administrator:

The final franchise agreement shall include a bonding requirement that ensures these kiosks can be removed without cost to the city should IKE go bankrupt or otherwise leave the City of Oakland;

- In addition to the prohibitions on advertising already in the draft agreement, the prohibition of specific types of advertising shall include no advertising of guns or ammunition, no advertising by fossil fuel companies, and no advertising for or against any candidate for elective office, no advertising paid for by an elected official, no advertising for or against any ballot measure, and no advertising that contains hate speech or sexually explicit content.*

(existing language: All Kiosk slides shall not display any advertisements that: (a) are contrary to any law, ordinance, rule or regulation of the City of Oakland, including the City Sign Code, or the State of California, (b) that promotes or advertises tobacco products, (c) promotes or advertises adult bookstores, adult cinemas or adult live entertainment venues, or (d) promotes a candidate for public office.)

- Striking the following sentence, "Grantee may elect to install additional Kiosks in excess of fifty (50) upon mutual agreement of Grantee and the City Administrator". thereby retaining Council authority to add or not add additional kiosks beyond 50.*

- IKE, in consultation with the city and city councilmember offices, shall conduct community engagement—including meetings in which the public is invited to attend—before finalizing the selection of sites of the kiosks. IKE shall consult with merchant associations, ethnic chambers of commerce, AC Transit, and established neighborhood groups when considering specific locations for kiosks. Further, Grantee shall coordinate with AC Transit on transit content on the kiosks.*

(existing language: Grantee shall consult with business improvement districts within the City of Oakland in making its determination on the most suitable locations for the Kiosks within each business improvement district.)

After discussion with OakDOT staff, Major encroachment permits would come to the Council in batches of 8-10 at a time.

*Ensure that none of the kiosks are installed on purely residential streets. Add duplexes and triplexes to the following sentence:
(existing language: In no event may Kiosks be located in front of single-family residences or K-12 schools.)*

Of the legislation, on page 11, Subsection R, to read, All structures shall be maintained free of visible mold due to moisture intrusion from rising of moisture from the ground, action of rain, exposed tops of walls, condensation, defective roof covering, inadequate slopes of roofs, or other construction defects.

On Page 14, item (11) to read, Dampness of habitable rooms due to building deficiencies (such as lack of moisture barrier on concrete slab);

On Page 15, Subsection E, to read, Hazardous Plumbing. Plumbing which was installed in violation of code requirements in effect at the time of installation; or plumbing not installed in accordance with generally accepted construction practices in areas where no codes were in effect; or which has not been maintained in good condition; or which is not free of cross-connections or siphonage between fixtures, shall be considered Substandard and a Public Nuisance.

On page 17, Section 15.08.520 - Definitions., In the first sentence, removing the term 'to a child'

On Page 18, third paragraph, "Lead Hazards" to read, includes deteriorated lead-based paint, lead-contaminated dust, and lead-contaminated soil, and also includes disturbing lead-based paint or lead contaminated soil without containment, or any other nuisance which may resulting in persistent and quantifiable lead exposure.

On Page 18, the last paragraph to read, "Presumed lead-based paint" means paint or surface coating affixed to a component in or on a structure constructed prior to January 1, 1978. All paint on buildings built before 1978 is presumed to be lead-based paint unless it has been tested in accordance with state law and has been shown to not be lead-based paint.

On Page 19, 15.08.540 - Inspection, to read as, A. If, upon visual inspection, the Building Official is persuaded that lead hazards are present, including but not limited to deteriorated lead-based or presumed lead-based paint, or the disturbance of lead-based paint without containment, the Building Official shall issue an order requiring the property owner to retain a third-party State of California certified Lead Risk Assessor to inspect and produce an lead risk assessment report.

B. The Building Official may also issue a Stop Work Order to prevent the further disturbance of lead-based or presumed lead-based paint without containment.
