RESOLUTION ACCEPTING AND CONFIRMING REPORTS OF THE CITY ADMINISTRATOR FOR DELINQUENT TRASH SERVICE FEES WITH ADMINISTRATIVE AND SPECIAL ASSESSMENT CHARGES AS NECESSARY PURSUANT TO CHAPTER 8.28 OF THE OAKLAND MUNICIPAL CODE, AND DIRECTING THE NOTICE OF SPECIAL ASSESSMENT CHARGES BE TURNED OVER TO THE COUNTY TAX COLLECTOR FOR COLLECTION FOR THE MONTHLY PERIODS OF JANUARY, FEBRUARY, AND MARCH 2021 AND QUARTERLY PERIODS OF APRIL-JUNE 2021

WHEREAS, pursuant to Chapter 8.28 of the Oakland Municipal Code ("OMC"), following an administrative hearing the City Administrator filed with the City Clerk on May 6, 2021 reports concerning delinquent trash service fees with added administrative and special assessment charges on hereinafter described real property; and

WHEREAS, attached hereto and incorporated herein is *Exhibit A*, which includes a listing of all properties subject to the special assessment levy by the County Assessor; and

WHEREAS, the date **June 15, 2021** and the time **1:30 p.m.**, was fixed as the day and hour of the public hearing for the Council to hear the reports concerning delinquent trash service fees with added administrative and special assessment charges, and any protests or objections to said reports; and

WHEREAS, pursuant to OMC Chapter 8.28 notice was served upon the owners of the premises to which the service was rendered not less than ten days prior to the date of the hearing; and

WHEREAS, no protests were made at said hearing; now, therefore be it

RESOLVED: That the reports which the City Administrator filed with the City Clerk on May 6, 2021 concerning delinquent trash service fees with administrative and special assessment charges for the real property described in Exhibit A, attached hereto and incorporated herein, be and are hereby accepted and confirmed, and the assessments are hereby authorized to be levied upon the properties described in Attachment A in the amount set opposite each description for costs incurred for delinquent trash service fees, with added administrative and special assessment charges; and be it

FURTHER RESOLVED: That if any special assessment levied on a property is not paid before the 10th day of August 2021, the City Administrator shall present an itemized report to the Auditor-Controller of the County of Alameda, State of California, to be placed on the 2021-2022 County Tax Roll.


