INTRODUCED BY COUNCIL PRESIDENT PRO TEMPORE NOEL GALLO

RESOLUTION RE-APPOINTING COUNCILMEMBER NOEL GALLO AS VOTING DELEGATE TO REPRESENT THE CITY OF OAKLAND AT THE ANNUAL LEAGUE OF CALIFORNIA CITIES' 2025 CONFERENCE OCTOBER 8-10, 2025 IN LONG BEACH, AND APPOINTING COUNCILMEMBER ROWENA BROWN TO REPRESENT THE CITY OF OAKLAND AS ALTERNATE VOTING DELEGATE, INCLUDING APPROVAL OF TRAVEL EXPENSES FOR ATTENDING 2025 CONFERENCE

WHEREAS, the City of Oakland is a Member City of the League of California Cities; and

WHEREAS, the Bylaws of the League of California Cities, Article V, Section 3 (a) state: "Designation. Each Member City may, with the approval of the city council, designate a city official as the city's designated voting delegate and, in the event that the designated voting delegate is unable to serve in that capacity, up to two alternate voting delegates;" and

WHEREAS, the City Council's Rules of Procedure, Rule 6 (Resolution, No 89588 C.M.S.) states that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council;" and

WHEREAS, on December 17, 2024, Council adopted its 2025 State and Federal Legislative Agenda that the Council appointees shall advocate for; and

WHEREAS, the Council President wishes to appoint Councilmember Noel Gallo as the City of Oakland's Voting Delegate, and Councilmember Rowena Brown as Voting Alternate to the Annual League of California Cities Conference from October 8-10, 2025; and

WHEREAS, City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010 establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging and of the cost of airline, lodging, per diem and conference fees when City funds are used as well as the source of City and/or Redevelopment Agency funding that will be used to cover the travel; and

WHEREAS, in compliance with Resolution No. 82800 C.M.S., the estimated costs for Councilmembers Noel Gallo are up to \$789 each for per diem (includes Lodging: \$189 per day and Meals & IE: \$74 per day) and up to \$650 for the councilmember's conference registration fees, and the source of City funding used to cover the travel costs will be from City Council Contingency Project fund; and

WHEREAS, Councilmember Gallo and Brown seek City Council approval of the aforementioned costs to travel to Long Beach, California to attend the California League of Cities 2025 Annual conference; now,

RESOLVED: That Councilmember Noel Gallo is hereby appointed the City of Oakland's Voting Delegate for the Annual League of California Cities' 2025 Annual Conference; and be it

FURTHER RESOLVED: Councilmember Rowena Brown is hereby appointed the city of Oakland's Alternate Voting Delegate for the Annual League of California Cities' 2025 Annual Conference; and be it

FURTHER RESOLVED: Councilmembers Gallo and Brown are authorized to travel to Long Beach, California, to attend the California League of Cities 2025 Annual Conference, and all expenses incurred by Councilmembers Gallo and Brown for said travel are hereby authorized.
