SUBJECT: A SUPPLEMENTAL REPORT AND RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF OAKLAND AND FAIRBANK, MASLIN, MAULLIN & ASSOCIATES, A PUBLIC OPINION RESEARCH FIRM, IN AN AMOUNT NOT TO EXCEED SIXTY THOUSAND DOLLARS (\$60,000), TO ADMINISTER A CITY OF OAKLAND CITIZENS SURVEY FOR THE PURPOSES OF GATHERING STATISITICS ON CITIZENS' EXPERIENCES

SUMMARY

At the December 14, 2004, Finance & Management Committee, staff presented a report recommending that City Council authorize the City Administrator to enter into a contract with Fairbank, Maslin, Maullin & Associates to conduct a City of Oakland Community Survey in an amount not to exceed \$60,000, to solicit feedback from Oakland residents which will assist with the budget development process and policy priorities.

The Finance & Management Committee directed staff to:

- Remove questions where the City of Oakland did not have direct jurisdiction.
- Forward the staff recommendation to include public safety related questions into the survey to the Public Safety Committee meeting that evening.

At the December 21, 2004, City Council meeting, the City Council directed staff to have two separate surveys, thereby removing specific questions about direct police citizen contact from the citywide survey.

Attachment A is the revised version of the draft survey for review. Staff also met with the Budget advisory Committee to solicit input on the questions; which is included as Attachment B.

FISCAL IMPACT

The total cost of services provided by Fairbank, Maslin, Maullin & Associates will not exceed \$60,000. Funding is available from the City Administrator's Office, Miscellaneous Contract Services, Fund 1010, Org. 90591, Account 54919, Project No. P58520

ACTION REQUESTED OF THE COUNCIL

This revised report recommends that City Council authorize the City Administrator to enter into a contract with Fairbank, Maslin, Maullin & associates, a public sector research firm, to conduct a City of Oakland Community Survey in an amount not to exceed \$60,000. City Council is also encouraged to review the draft survey questions in Attachment A to determine if the questions listed will meet their needs for feedback from Oakland residents on the budget development process and policy priorities.

The BAC has the following suggestions for the survey. These are not listed in any particular order.

- 1. Include in the contract the requirement that the demographics of the survey population (e.g. age, home ownership, educational attainment, etc. as captured in questions 23-35) be cross-tabulated with the most recent census data for Oakland. This will enable the City to determine how accurately the sample represents the City. This should be included in the contract so as not to become an added cost later.
- 2. In order for results from these surveys to be useful in the budget process, the BAC recommends that in future such surveys be conducted earlier in the budget cycle. This would allow the results to be used in the strategic planning of the budget.
- 3. Modify question number 4 of the survey, which asks the responder to list the three most serious issues facing residents of Oakland that the responder would like to see prioritized in the City's budget, to specifically exclude education as a response. In the 2002 survey, education was one of the top responses. However, education is not a City function, and this result might have obscured other responses that would have been more relevant to the City.
- 4. The BAC suggests adding the following questions:
 - a. How important is it for Oakland to keep major league sports teams in the City?
 - b. How important is public transportation to the vitality of the City?
 - c. Should the City spend money to attract and to keep businesses in Oakland?
 - d. The BAC also recommends a question where the already-identified core functions of the City are listed, and the responder is asked to rank them in order of importance.
 - 5. The BAC also believes that shorter, more focused surveys would be very helpful. In particular, a survey on the business environment. Should we try to attract and keep businesses? What do businesses want? What do they not care about? Also, a survey on redevelopment would be useful.

2004 DEC 29 RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF OAKLAND AND FAIRBANK, MASLIN, MAULLIN & ASSOCIATES, A PUBLIC OPINION RESEARCH FIRM, IN AN AMOUNT NOT TO EXCEED SIXTY THOUSAND DOLLARS (\$60,000), TO ADMINISTER A CITY OF OAKLAND CITIZENS SURVEY FOR THE PURPOSES OF GATHERING STATISITICS ON CITIZENS' EXPERIENCES

WHEREAS, it is the intention of the City Administrator to conduct a City-wide survey to determine Oakland residents' level of satisfaction with City services; and

WHEREAS, the survey will provide valuable data about citizens' perceptions in the areas of public safety, parks, arts and crafts, and economic development; and

WHEREAS, the results from the survey will be used when developing the City's next biennial budget; and

WHEREAS, the results of the survey will be used to analyze department performance measures; and

WHEREAS, the 2005 Citizens' Survey will be administered to 1,000 Oakland households, with a sample weighting process to reflect the City's demographic composition; and

WHEREAS, the 2005 survey allows for comparison with surveys conducted in 1995, 2000 and 2002, and will be used as a benchmark for future years; and

WHEREAS, budgeted funds are available from the City Administrator's Office, Miscellaneous Contract Services, Fund 1010, Org. 90591, Account 54919, Project No. P58520; and

WHEREAS, the City Council hereby finds and determines that services provided pursuant to the contact authorized hereunder are of a professional, scientific or technical nature and are temporary in nature; and

WHEREAS, the City Council hereby finds and determines that the contracts awarded hereunder shall not result in the loss of employment or salary by any person having permanent status in the competitive services; and

WHEREAS, the City Council finds that the service is exempt from competitive bidding pursuant to Section 2.04.050 I of the Oakland Municipal Code; now, therefore, be it

RESOLVED: That the City Administrator is hereby authorized to negotiate and enter into an agreement in an amount not to exceed sixty thousand dollars (\$60,000), with Fairbank, Maslin, Maullin & Associates, a public opinion research firm, to conduct a City-wide citizens' survey in Oakland during the period between January 11, 2005 and February 28, 2005; and, be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator to execute any further documents necessary to implement this resolution; and, be it

FURTHER RESOLVED: That the City Administrator is authorized to modify, extend or amend said agreement provided that no additional funds will be allocated without prior Council approval: and, be it

FURTHER RESOLVED: That the agreement shall be reviewed by the City Attorney as to form and legality and a copy placed on file in the Office of the City Clerk.
