**A RESOLUTION COMMENDING ANDREA YOUNGDAHL, DIRECTOR OF THE DEPARTMENT OF HUMAN SERVICES, FOR 11 YEARS OF OUTSTANDING SERVICE AND CONGRATULATING HER ON THE OCCASION OF HER RETIREMENT**

**WHEREAS**, Andrea Youngdahl has over 33 years of professional experience in the social and human services field, and as the Director of the Department of Human Services, has directed the delivery of a broad range of human services to address the quality of life of Oakland's residents; and

**WHEREAS**, in 1985, Andrea Youngdahl completed a Masters of Social Work at California State University, San Francisco, and since that time and throughout her career has been a tireless advocate for children, youth and families, adults and seniors, through her work on behalf of Head Start and early care education, early childhood mental health, family support and literacy, child and youth development, violence prevention and reentry, a variety of senior services including senior employment, senior centers, and case management services, services for vulnerable populations including the homeless and those with special needs; and

**WHEREAS**, Andrea Youngdahl is highly regarded as an outstanding public administrator for successfully leading and coordinating many interagency efforts and collaborations with other state, county and local agencies; for securing millions of dollars in grant funds annually to benefit the children, families, adults, and seniors of Oakland; and for advancing the development and improvement of services and systems of care through successful partnerships with many public agencies and community services providers; and, has been recognized for her dedication, brilliance, hard work, and contributions by the California State Assembly and many other offices and agencies; and

**WHEREAS**, Andrea Youngdahl has administered the Department of Human Services to the meet the highest of standards evidenced by numerous successful federal, state, and local audits, and has directed the administration of community services to the highest standards of accountability and customer service, and has demonstrated professional excellence and leadership in public service throughout her tenure with the City of Oakland; and

**WHEREAS**, after 11 years in public service to the City and its residents, Andrea Youngdahl has decided to retire and will be greatly missed by all who have worked with her and been inspired by her; now, therefore, be it


