RESOLUTION WAIVING THE COMPETITIVE MULTIPLE STEP SOLICITATION PROCESS AND THE LOCAL/SMALL LOCAL BUSINESS ENTERPRISE REQUIREMENTS AWARDING A PROFESSIONAL SERVICES AGREEMENT TO AXON ENTERPRISE IN AN AMOUNT NOT-TO-EXCEED FORTY THOUSAND DOLLARS (\$40,000) TO PROVIDE AUDIO AND VIDEO RECORDING OVER A FIVE-YEAR TERM, FROM OCTOBER 1, 2024 TO OCTOBER 1, 2029

WHEREAS, the Oakland Police Department (OPD) currently utilizes the CaseCracker system to record interviews in its Criminal Investigation Division (CID), but the current system is outdated, resulting in limited functionality and data security issues; and

WHEREAS, OPD requires a new, integrated solution for audio and video recording in interview rooms, which Axon Enterprise can provide, alongside cloud storage through Evidence.com, improving efficiency and data protection; and

WHEREAS, Axon Enterprise already provides body-worn camera solutions for OPD, with seamless integration into Evidence.com, making them a compatible and trusted provider for interview room recordings; and

WHEREAS, the OPD has determined that using Axon's solution will improve the investigative process and reduce the workload for CID investigators, who currently rely on manual processes for data storage and redundancy; and

WHEREAS, the contract will cost \$40,000 per year for five years, for a total not-to-exceed amount of \$200,000, with grant funding secured for this project; and

WHEREAS, awarding this contract will help the OPD maintain efficient, transparent, and secure handling of interview recordings while addressing critical operational needs in the Criminal Investigation Division; now, therefore, be it

WHEREAS, Oakland Municipal Code ("OMC") Section 2.04.042.B requires the City Administrator to conduct a multi-step proposal solicitation process before selecting a vendor or procuring Information Technology ("IT") systems, software or hardware and OMC Section 2.04.042.D allows the City Council to waive the proposal solicitation requirements upon a finding by the Council that it is in the best interest of the City to do so; and

RESOLVED: That the City Council authorizes the City Administrator to enter into a contract with Axon Enterprise for an amount not-to-exceed \$40,000 annually for five years, and

RESOLVED: That the City Council hereby awards a Professional Services IT Agreement to Axon Enterprise in an amount not to exceed \$40,000 per year to provide data management services from October 1, 2024 to October 1, 2029; and be it be it

FURTHER RESOLVED: The funding will be paid from the General-Purpose Fund (1010), Organization (102310), Miscellaneous Services Account (54919), Project (1000008), Program (PS03).

FURTHER RESOLVED: That the City Council waives the Local and Small Local Business Enterprise Program and RFP/Q process requirements for this contract in the best interest of the City of Oakland.
