RESOLUTION NO. 89468 C.M.S.

INTRODUCED BY VICE MAYOR KAPLAN

**RESOLUTION APPROPRIATING AND ALLOCATING AN AMOUNT NOT TO EXCEED \$45,000 FROM THE AFFORDABLE HOUSING TRUST FUND, REDEVELOPMENT DISSOLUTION FUNDS, FOR FISCAL YEAR 2022-2023, AND AUTHORIZING A GRANT IN THAT AMOUNT TO CO-APPLICANTS TO ASSIST IN OBTAINING SITE PREPARATION DOCUMENTATION, INCLUDING BUT NOT LIMITED TO, SITE SURVEYS AND APPRAISALS, FOR CITY-OWNED LAND LOCATED AT 9418 EDES AVENUE AND 606 CLARA STREET WHICH MAY BE USED FOR POSSIBLE FUTURE PROJECTS UNDER THE STATE OF CALIFORNIA HOMEKEY PROGRAM**

**WHEREAS**, as of the most recent point-in-time count from February 2022, Oakland had 5,055 individuals experiencing homelessness, which represents approximately 52% of the total homeless population in Alameda County; and

**WHEREAS**, homelessness has long-term and serious consequences to the health and safety of those who experience it, and are at risk of health problems including life-long behavioral health challenges; and

**WHEREAS**, in response to the mounting challenges around homelessness, in July of 2020, the State of California launched its Homekey initiative, allocating funding to allow local public agencies to buy underused properties, and develop a broad range of housing types - including but not limited to hotels, motels, hostels, single-family homes and multifamily apartments, adult residential facilities, and manufactured housing - to convert commercial properties and other existing buildings and vacant land to permanent or interim affordable housing; and

**WHEREAS**, Homekey has been lauded for allowing local jurisdictions to develop housing strategies that best fit the needs of their homeless populations, available resources, and market conditions; and

**WHEREAS**, Oakland is among the jurisdictions facing multiple extraordinary challenges when it comes to meeting its housing needs: the COVID-19 pandemic, gentrification and displacement, high rates of unemployment, and lack of sufficient affordable housing; and

**WHEREAS**, the City's top policy objective when surveying potential uses for city-owned land is utilizing land to address housing and shelter inequities, as outlined in the March 2016 report on the City's Public Lands Policy Framework, and underscored in the August 2019 informational memorandum on the status of the Public Lands Policy Ordinance; and

**WHEREAS**, the Oakland City Council adopted Resolution No. 89087 C.M.S. to authorize including the value of City-owned public land for the purpose of the local match as a part of Homekey applications, permit the City Administrator to obtain appraisals of City-owned property intended for Homekey projects, and dedicate multiple publicly-owned parcels to be used for deeply affordable housing; and

**WHEREAS**, Resolution No. 89087 C.M.S also provided the City Administrator authority to complete any needed environmental review, land surveys, and geotechnical reports for City properties seeking affordable housing funding; now, therefore, be it

**RESOLVED:** That the Oakland City Council appropriates and allocates an amount not to exceed \$45,000 from the Affordable Housing Trust Fund, Redevelopment Dissolution Funds 2022-2023 (Fund 1870, Project 1000386, Org 89929) for a grant to co-applicants to assist in obtaining site preparation documentation, including but not limited to, site surveys and appraisals, for the City-owned site located at 9418 Edes Avenue and 606 Clara Street, which may be used for possible future projects under the State of California Homekey Program, and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to negotiate and enter into a grant agreement and other documents for this grant, and take whatever other action is necessary with respect to the grant consistent with this Resolution and its basic purposes.


