Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Thirty-five Thousand Dollars and No Cents (\$35,000.00) payable to Plaintiff Doree Johnson and Matthew D. Haley, her attorney.

This action arises from an incident on May 17, 2007, wherein Ms. Johnson tripped and fell over a portion of upraised sidewalk adjacent to 4529 Martin Luther King Jr. Way. This matter was not heard in closed session.
