

RESOLUTION AUTHORIZING AN AGREEMENT WITH TRAVELERS AID SOCIETY OF ALAMEDA COUNTY, INC. IN AN AMOUNT NOT TO EXCEED \$358,620 FOR THE PERIOD OF JULY 1, 2003 THROUGH JUNE 30, 2005 FOR THE HOMELESS MOBILE OUTREACH PROGRAM.

WHEREAS, during the budget process in June 2001, the City Council authorized an appropriation of \$358,620 to fund the Homeless Mobile Outreach Program for fiscal years 2001/2002 and 2002/2003 (Fund 1010, Organization 88959, Project G142710); and

WHEREAS, the Policy Budget for Fiscal Years 2003/2004 and 2004/2005 authorizes continuation of the Homeless Mobile Outreach Program; and

WHEREAS, there is a continuing need for provision of these services to the homeless and those at-risk of homelessness; and

WHEREAS, the City Council finds that contracts for these services are of a professional nature; and the City Council finds that these contracts shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now therefore, be it

RESOLVED, that the City Manager is hereby authorized to enter into an Agreement with Travelers Aid Society of Alameda County, Inc. in an amount not to exceed \$358,620 for the period of July 1, 2003 to June 30, 2004, and, if service has been satisfactory, for the period of July 1, 2004 through June 30, 2005, for the Homeless Mobile Outreach Program; and be it

FURTHER RESOLVED, that the City Manager is authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary in accordance with the Agreement's basic purpose; and be it

FURTHER RESOLVED, that said funds in the amount of \$358,620 for the Homeless Mobile Outreach Program for fiscal years 2003/2004 and 2004/2005 be allocated to Fund 1010, Project G142730; and, be it

FURTHER RESOLVED, that said Agreement(s) shall be approved as to form and legality by the Office of the City Attorney and placed on file with the office of the City Clerk.
