**RESOLUTION HONORING MARIANNA A. MARYSHEVA FOR HER  
DISTINGUISHED SERVICE TO THE CITY OF OAKLAND**

**WHEREAS**, Marianna A. Marysheva joined the City Manager's (now City Administrator's) Budget Office in November 2000, having received a Master of Public Policy degree from the Richard and Rhoda Goldman School of Public Policy from the University of California at Berkeley; and

**WHEREAS**, Marianna's impressive intellect, sound judgment, and commitment to public service led to her significant accomplishments in the City, including her appointment as Budget Director in 2001 and her appointments to numerous national boards and committees of government financial officials; and

**WHEREAS**, through Marianna's persistence, leadership, and vision, she spearheaded the City's effort to transition the City's Policy Budget from a line-item to a program-based, performance-based budget, consistent with best practices in public budgeting; and

**WHEREAS**, through tireless effort, Marianna led a team of 15 staff through the perilous waters of necessary yet painful budget cuts to produce three balanced, transparent, award-winning Biannual Budgets for the City and Redevelopment Agency, in which some \$70 million in expenses were reduced from the City's operating budget over five years; and

**WHEREAS**, Marianna has demonstrated cross-agency leadership through her role in the City's Moving Oakland Forward strategic planning process, which resulted in the adoption and implementation of several key initiatives by the City Council and City Administrator, including balancing many of the City's negative funds and establishing repayment plans for others; and

**WHEREAS**, Marianna has contributed immeasurably to the general understanding of public finance among City staff, elected and appointed officials, as well as finance professionals throughout the United States by delivering superior training on budget development, implementation, and monitoring; and

**WHEREAS**, she has inspired the devotion of her staff, the respect of her colleagues, and the admiration of her superiors through her unflagging work ethic, unmatched standard of excellence and unflappably amiable demeanor; and

**WHEREAS**, Marianna shows genuine compassion and caring for those around her and has nurtured her staff to develop professionally and personally to their fullest potential; now therefore be it

**RESOLVED**: That the City Council and City Administrator do hereby commend Marianna Marysheva for her unparalleled commitment to excellence in the public sector, and bountiful contributions to the City and citizens of Oakland; and be it further

**RESOLVED**: That a copy of this Resolution, suitably inscribed, be presented to Marianna Marysheva with the compliments of the City Council and City Administrator as a token of their appreciation and high esteem, and with best wishes for her continued success and illustrious career in public administration.
