

**ADOPT A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR DESIGNEE TO EXECUTE PROFESSIONAL SERVICES AGREEMENTS FOR ON-CALL GEOTECHNICAL ENGINEERING SERVICES WITH ONE (1) FIRM FOR TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) WITH:
1) PARIKH CONSULTANTS, INC.**

WHEREAS, professional on-call geotechnical engineering services are needed to provide geotechnical engineering services on various projects. The services are needed to design and review roadway damage and slope stability restoration projects; and

WHEREAS, on-call geotechnical engineering services allow Oakland Department of Transportation (OakDOT) to respond and provide the necessary services in an efficient and timely manner; and

WHEREAS, on-call geotechnical engineering services allow OakDOT to promote greater efficiency and safety within the transportation network; and

WHEREAS, OakDOT anticipates that the possibly of severe winter storms may cause landslides and collapse roadways, will utilize the on-call geotechnical engineering services contracts; and

WHEREAS, mid-year projects will arise throughout the three-year period will likely require on-call geotechnical engineering services; and

WHEREAS, on-call geotechnical engineering services will be funded through the various individual projects and funds will be identified prior to the performance of the on-call services; and

WHEREAS, the City issued a Request for Qualifications (RFQ) in accordance with Oakland Municipal Code, OMC Chapter 2.04.051; and

WHEREAS, through the City's Request for Qualifications process, one Tier I firm met the requirements of OMC Chapter 2.04.045(a) for pre-qualification for on-call geotechnical engineering services; and

WHEREAS, the City Council finds that the services provided pursuant to the contracts authorized hereunder are of a professional, scientific or technical nature and are temporary in nature; and

WHEREAS, the City Council finds that the contracts shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore be it

RESOLVED: That the City Council authorize the City Administrator to execute a Professional Services Agreement Contract with On-Call Geotechnical Engineering Services to one Tier I firm: Parikh Inc.

FURTHER RESOLVED: That the total amount of the Contract for one Tier I firm shall be for a not-to-exceed amount of \$250,000; and be it

FURTHER RESOLVED: That the terms of each Contract shall be for three (3) years; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to approve any subsequent amendments to or extensions of said Contracts with the exception of those related to an increase in total compensation or the allocation of funds, provided that such amendments or extensions shall be approved for form and legality by the City Attorney and a copy shall be kept on file with the City Clerk; and be it

FURTHER RESOLVED: That the Contracts shall be approved for form and legality by the City Attorney, and a copy shall be kept on file with the City Clerk.


