RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO ACCEPT AND APPROPRIATE GRANT FUNDS IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED FIFTY-FOUR THOUSAND NINE HUNDRED AND SIXY-FIVE DOLLARS (\$454,965) FROM THE U.S. DEPRATMENT OF JUSTICE, NATIONAL INSTITUTE OF JUSTICE (USDOJ/NIJ) FOR IMPLEMENTATION OF THE FY 2008 SOLVING COLD CASES WITH DNA GRANT PROGRAM IN THE POLICE DEPARTMENT AND APPROVING THE HIRING OF ONE FULL-TIME, EIGHTEEN-MONTH LIMITED DURATION PROFESSIONAL STAFF POSITION FOR THE RESEARCH, PLANNING, AND CRIME ANALYSIS DIVISION

WHEREAS, it is anticipated that grant funds in an amount not to exceed \$454,965 shall be awarded by the U.S. Department of Justice, National Institute of Justice, in support of the Police Department's FY 2008 Solving Cold Cases with DNA program; and

WHEREAS, the FY 2008 Solving Cold Cases with DNA grant program was created to assist local law enforcement agencies to readily identify, review, and investigate violent crime "cold cases" that have the potential to be solved using DNA analysis; and

WHEREAS, the grant term for the proposed initiative is October 1, 2008 through March 30, 2010; and

WHEREAS, the State of California, Office of Criminal Justice Planning, previously awarded the Police Department a grant in the amount of \$650,483 to fund a three-year Cold Hit Program within the Department's Criminalistics Laboratory; and

WHEREAS, the City Council previously authorized acceptance of those grant funds by Resolution No. 76294 C.M.S., dated February 20, 2001, for the period October 1, 2002 through September 30, 2003; and

WHEREAS, the U.S. Department of Justice, National Institute of Justice, previously awarded the Police Department a grant in the amount of \$273,870 to fund the FY 2007 Solving Cold Cases with DNA grant program; and

WHEREAS, the City Council previously authorized acceptance of those grant funds by Resolution No. 80870 C.M.S., dated October 2, 2007, for the period October 1, 2007 to March 30, 2009; and

WHEREAS, the Department is requesting authorization to add one full-time, limited duration professional staff (civilian) position to the Police Department staff who will be assigned to the Research, Planning, and Crime Analysis Division and funded by the FY 2008 Solving Cold Cases with DNA grant for up to eighteen months; and

WHEREAS, the proposed grant does not allow for indirect costs (Central Services Overhead) charges in the amount of \$56,133, and the Department has requested a waiver of said charges; now, therefore be it

RESOLVED: That the City Council hereby authorizes the City Administrator or her designee to accept grant funds in an amount not to exceed \$454,965 from the U.S. Department of Justice, National Institute of Justice, and to increase revenues and appropriate said budget to the Police Department; and be it

FURTHER RESOLVED: That Central Services Overhead costs of \$56,133 are hereby waived; and be it

FURTHER RESOLVED: That said grant funds shall be maintained in the Federal Grant Fund: 2112; Criminalistics Division Org.: 102610; Criminalistics Division Program: PS05; in a Project Number to be established; and be it

FURTHER RESOLVED: That the City Administrator, or her designee, is hereby authorized to add one full-time, limited duration civilian position (one Administrative Analyst II) to the Police Department staff who will be assigned to the Research, Planning, and Crime Analysis Division, and funded by the FY 2008 Solving Cold Cases with DNA grant for up to eighteen months; and

FURTHER RESOLVED: That the City Administrator or her designee is hereby authorized to complete all required negotiations, certifications, assurances, and documentation required to accept, modify, extend and/or amend the grant award.
