Pursuant to Section 401 of the Charter, the City Attorney recommends settlement of the above-entitled matter arising out of the confiscation of property at the residence of 5268 Shafter Avenue on May 27, 2000. Plaintiffs claim that the seizure was illegal, and that their subsequent arrest was without basis.

Due to the risk of an adverse jury verdict, settlement is recommended in the amount of Fifteen Thousand Dollars (\$15,000.00), payable to Daniel Hagen, Lynda O'Neil, and William G. Panzer, their attorney of record.

The matter was heard in closed session on December 21, 2004.
