## Interests & Experiences

### Please tell us how your qualifications and participation will relate to the requested board and/or commission's mission.

Who am I? My husband and I moved to Oakland in May 2022. By day, I am a patent litigation attorney working in a boutique law firm in San Francisco. By night, my husband and I are the primary caregivers to our 80 year-old grandmother and our two huskies (Merlin and Remy). I am also a regular volunteer at the Alameda Food Bank. Why am I interested in PAC? I first developed an interest in privacy issues over a decade ago during my very first encounter with the police body camera in Beijing, China (years before such cameras were introduced in US). As I was about to fly back to Toronto after visiting families in China, a police officer at the Beijing Airport pulled me aside and informed me that I had an "illegal artifact" in my checked bag (a handcrafted Tibet Knife my late-father gifted me on my 13 year-old birthday). I soon noticed that the police officer was wearing a body camera (aiming at my face), and he was manually turning it on and off at certain points of our conversation. Five minutes in, it finally occurred to me that the police officer was trying to record only the portion where I made "admissions" (e.g., admitting that I was trying to leave the country with the Tibet Knife) and leave out anything that could put doubt to the legitimacy of his questioning (e.g., threatening to put me in jail and hinting about the bribery that I could offer). To this day, this experience (and the realization how footage collected in such a matter can be abused) still sends chills to my spine. During law school, I further explored various privacy issues relating to the then-emerging technologies (e.g., autonomous vehicles, drones, and police body cameras) as a member of the Technology Law and Public Policy Clinic. Needless to say, when my husband and I were browsing the City of Oakland website for local volunteer opportunities, I was immediately drawn to the Privacy Advisory Commission's mission and its fascinating history. What can I offer to PAC? As an litigation attorney, I am fairly good at legal research as well as conducting factual investigations, such as identifying and organizing key facts and evidence collected from disbursed publicly available sources. "Issue spotting" and devising practical solutions are also major parts of my daily job, which I believe can be readily applied to the PAC's work. Though privacy law is not the focus of my practice, I have developed a high-level understanding of the lay of the land as an Certified Information Privacy Professional. I do follow the development of privacy

laws and cases as well as routinely attend privacy-focused trainings and conferences (e.g., the upcoming Annual Privacy Summit organized by the California Lawyers Association). I am also a member of our firm's Data Protection Committee where I help preparing training programs on data protection and cybersecurity issues. A Few Thoughts on PAC's Work As I went down the rabbit hole reading up on the PAC's history, I was actually shocked by the numerous stories describing PAC's struggle with the resource and bandwidth constraints (which prompted me to reach out to Mr. Hofer to offer my help as a private citizen). While I am not sure if I will have the honor to be a member of the PAC, I do wish to offer a few recommendations, which hopefully can alleviate these resource/bandwidth constraint issues to a certain extent: (1) Establishing an online portal/platform for accepting and publishing written submissions from the public. Before a federal agency conduct major rulemakings, such an agency is generally required to publish a notice for collecting public's written comments (especially from the interested parties). Most agencies' websites provide simple and intuitive submission mechanism for comment collection and publication. I believe PAC may be able to benefit from such a portal/platform in three aspects: (a) interested parties before the PAC can utilize such submissions to fully lay out its positions and arguments relating to the business it has before PAC; (b) Oakland citizens can help PAC with fact-findings and feedback gatherings via such submissions; and (c) PAC can also invite experts (in privacy law or certain technology) to provide input via such submissions. (2) Engaging law school clinics and privacy-law focused bar associations. Most major law schools have technology law related clinics with faculty and students interested in the intersection of technology, public policy, law, and privacy issues. Numerous bar associations and organizations also specifically focus on the development and application of privacy laws. Both type of organizations may be great resources for providing subject matter expertise on issues/questions that PAC faces in its daily work. (3) Liaison with other privacy-focused regulatory agencies. With the enactment of various new privacy laws, new regulatory agencies are also established for promulgating and enforcing privacy regulations (e.g., the California Privacy Protection Agency Board and the California DOJ Privacy Unit). While these regulatory agencies' work do not overlap with PAC's work for the most part, these agencies may have valuable insights on privacy protections that could help PAC's work. I believe establishing certain communication channel and liaison with these agencies may benefit PAC in the long term.
