A RESOLUTION AUTHORIZING CAPITAL IMPROVEMENT SPENDING FOR THE OAK CENTER REDEVELOPMENT PROJECT AREA, IN AN AMOUNT NOT TO EXCEED \$600,000, INCLUDING A CONTRACT TO IMPROVE THE OAK CENTER CULTURAL CENTER, INC. FOR \$50,000, AND AUTHORIZING THE AGENCY ADMINISTRATOR TO ENTER INTO CONTRACTS FOR THE WORK WITHOUT RETURNING TO THE AGENCY, AND

A RESOLUTION CONSENTING TO THE USE OF REDEVELOPMENT AGENCY FUNDS FOR PUBLIC IMPROVEMENTS TO CITY FACILITIES IN THE OAK CENTER REDEVELOPMENT PROJECT AREA

#### **SUMMARY**

This report has been prepared to authorize staff to spend \$600,000 for capital improvements in the Oak Center Redevelopment Project area to 1) provide signage and landscape improvements to identify the area as a historic preservation district through a design and build professional services agreement, 2) repair and upgrade the Oak Center Cultural Center, 3) provide public and neighborhood improvements, and 4) enter into agreements for designing and building the historic district demarcation and for repairs and upgrades to the Oak Center Cultural Center. Staff also requests authorization to appropriate \$282,510 from the Oak Center Redevelopment Project fund balance.

#### FISCAL IMPACT

Funds for this redevelopment project area are realized through property tax increments (Oakland Redevelopment Agency budget, Fund 9552, Organization 88919, ORA, Oak Center).

The funds for this activity were budgeted in the 2001-03 budget (\$512,000) and in the 2004 budget (\$100,000). Of the \$512,000 from 2001-03, \$229,490 was carried forward and is available for these projects. In order to make these funds available for this purpose, legislation included with this report appropriates \$282,510 from the fund balance for the Oak Center Redevelopment Project.

By taking the action requested here \$612,000 will be available for the capital improvements in the Oak Center Redevelopment Area. (This report allocates \$600,000 of those funds.)

#### **BACKGROUND**

The Oak Center Redevelopment Project area is a 56-block residential community in West Oakland adjacent to downtown and the Acorn Project, bounded by 18<sup>th</sup> and 20<sup>th</sup> Streets, 10<sup>th</sup> and 12<sup>th</sup> Streets and Brush and Union Streets. The neighborhood is mainly composed of turn-of the century Victorian structures that have been well preserved through multiple efforts and a variety of financing techniques. The Redevelopment Plan was adopted in 1965 and amended in 1970. Many structures were not feasible for rehabilitation and were demolished. The Project is mainly complete, except for a few parcels that remain to be developed. Since the Plan for the redevelopment area is basically complete, the principal remaining activity is monitoring compliance with the Plan and providing support services to the Oak Center Neighborhood Association (OCNA).

In order to enhance development within the area and to further the goals of the Plan, the community requested to have the area designated as a Historic District. The OCNA worked with staff and achieved status as a Historic Preservation Area July 2003. Historic district designation places the district's Designated Historic Properties (DHPs) on the Local Register of Historical Resources.

The Oakland City Council voted unanimously to make Oak Center a historic district in June 2003. The area includes nine houses that were already individually designated as City landmarks. Out of 600 buildings in the district, 427 (71%) date from the 19<sup>th</sup>-early 20<sup>th</sup> century period.

#### **KEY ISSUES AND IMPACTS**

The Oak Center Cultural Center (1121 14<sup>th</sup> Street, AKA 1324 Adeline Street) was transferred from the City to the Oak Center Cultural Center, Inc. (OCCCI) by quitclaim deed May 31, 2002, in accordance with the 20-year Lease Agreement adopted July 6, 1982 by Ordinance No. 10235 C.M.S.

According to the terms of the transfer agreement, the Cultural Center must continue to be operated as a multi-purpose facility providing health, welfare, recreational, cultural, social, and/or other similar community services, including meeting space for community organizations.

No commercial uses are allowed. No improvements have been made in quite some time. Funds are being requested for repairs and upgrades to improve the appearance and make it a more desirable facility. The Agency will issue a contract to Oak Center Cultural Center, Inc. to repair the Center.

The major portions of the improvements are related to the historic district identification. Agency staff will work with the community and the Public Works Project Delivery Division to develop the scope of work; the items that will be included are listed under the Project Description section of this report. Public Works will either utilize as-needed existing consultants or issue a Request for Proposal (RFP) for a contractor to design and build the project. This gateway to the historic district may include reuse of materials to mark the entry into Oak Center.

The Oak Center Neighborhood Association has recommended capital improvements at DeFremery Park, a City-owned property. Section 33445 of the Health and Safety Code requires the consent of the City Council before the Agency can make improvements to City facilities, and the City Council must make certain findings. Section 33679 requires a public hearing.

The Health and Safety Code requires that a summary shall be available for public inspection and copying, that includes:

- a) Estimates of the amount of the taxes proposed to be used to pay for land and construction of any publicly owned building, including interest payments. The amount being allocated for DeFremery Park is \$600,000.
- b) The facts supporting the determinations required to be made by the legislative body pursuant to Section 3345.

The findings to be determined are that:

- i) The funding of capital improvements to City buildings and facilities in the Oak Center Project Area will benefit the Project Area by providing signage and landscape improvements to identify the area as a historic preservation district, and provide needed public and neighborhood improvements at DeFremery Park; and
- ii) No other reasonable means of financing these capital improvements are available to the City other than Redevelopment Agency funding, because funding has not been identified or set aside from any other source; and
- iii) The use of tax increment funds from the Oak Center Project Area will assist in the elimination of blight by helping to preserve the historic beauty of the community, and is consistent with the implementation of the Plan adopted for the Oak Center Project.
- c) The redevelopment purpose that taxes are being used to pay for the land and construction of the publicly owned building.

#### PROJECT DESCRIPTION

Capital improvements in the Project Area include Historic District Demarcation, the Oak Center Cultural Center, Inc., and improvements at DeFremery Park.

Historic District Demarcation - signage, markers, archways and lights, etc. including:

- 1. Design plan to tie signage components together in theme and character.
- 2. Gateway signage in the median at 14<sup>th</sup> Street & Brush to include sculpture, arch or similar feature, preferably by local artists.
- 3. Mid-scale signage at major entry points to the district (14<sup>th</sup> Street, Adeline and Market, 12<sup>th</sup> and Brush.
- 4. Interpretive signage at DeFremery Park to include the history of Oak Center and a map of the district, etc.
- 5. Sign caps on street signs at intersections.
- 6. Plaques for the nine Landmark homes in the district.
- 7. Smaller plaques for contributing buildings in the district.
- 8. Freeway signs.

#### SUSTAINABLE OPPORTUNITIES

Economic: The historic preservation items will generate a professional services contract for designing and building the work. Historic designation encourages careful rehabilitation of buildings that will create opportunities for skilled employment.

Environmental: Construction contractors are encouraged to use recycled-content building materials and products manufactured in ways that are not harmful to the environment.

Social Equity: Improves the landscape and climate of the neighborhood, increased sense of pride that may also result in fewer blighted buildings and lots.

#### DISABILITY AND SENIOR CITIZEN ACCESS

There are no direct accessibility impacts to seniors or people with disabilities related to this report. Many of Oak Center's senior residents have lived in the area since the redevelopment era of the 1960s and 70s. This designation honors their longtime commitment to the neighborhood.

#### RECOMMENDATION

These expenditures will help preserve the historic beauty of the community. Staff recommends that the Agency adopt the resolution authorizing staff to work with City agencies and enter contract agreements to facilitate improvements in the Oak Center Redevelopment Project Area to identify it as a historic preservation district and provide upgrades, repairs and improvements to the community and the Oak Center Cultural Center, Inc.



WHEREAS, the Oak Center Urban Renewal Plan was adopted by the Oakland City Council on November 30, 1965 and amended September 15, 1970; and

WHEREAS, ownership of the Oak Center Cultural Center was transferred to the Oak Center Cultural Center, Inc. on May 31, 2002 in accordance with the Lease Agreement adopted July 6, 1982 by Ordinance No. 10235 C.M.S.; and

WHEREAS, the Oak Center Redevelopment Area was designated as the Oak Center Historic District by Ordinance No. 12513 C.M.S. July 15, 2003; and

WHEREAS, the Oak Center Neighborhood Association and staff wish to obtain signage, lighting and markers to identify the area as a historic district, and implement other capital improvements, repairs and upgrades in the Project Area, including improvements to the Oak Center Cultural Center; and

**WHEREAS**, funds for these activities are available in Fund 9552, Organization 88919, for operation and maintenance; and

WHEREAS, the Agency wishes to authorize the use of up to \$600,000 from current Oak Center funds to fund these activities; and

- WHEREAS, Section 33445 of the California Health and Safety Code authorizes a redevelopment agency to pay for the cost of installation or construction of publicly-owned facilities, if the legislative body has consented to such funding and has made certain findings; and
- **WHEREAS**, Section 33679 of the California Health and Safety Code authorizes a redevelopment agency to pay for the cost of installation or construction of publicly-owned buildings, if the legislative body has held a hearing on the funding; and
- WHEREAS, the City Council has held the required public hearing, has consented to the use of Agency funding for these project activities, and has made the requisite findings; and
- WHEREAS, the Oak Center Cultural Center is within the boundaries of the Oak Center Redevelopment Project Area, and these capital improvements will contribute to the Agency's goals and objectives for the Project Area; and
- WHEREAS, the City and the Redevelopment Agency have entered into a Repayment Agreement for the Oak Center Redevelopment Project providing for the provision of funding and services by the City and the Agency to support redevelopment activities in the Oak Center Project Area; and
- WHEREAS, an agreement will be negotiated with a contractor to design plans to coordinate the construction to identify the area as a historic district, and the Agency will enter into a contract for \$50,000 with the Oak Center Cultural Center, Inc. to repair the facility; now, therefore, be it
- **RESOLVED:** That Agency hereby approves and commits the use of funds from the Redevelopment Agency Oak Center fund (Entity 5, Fund 9552) in an amount not to exceed \$600,000, including appropriating \$282,510 from fund balance, to undertake the capital improvements to the Oak Center Project Area as set forth in the staff report accompanying this Resolution; and be it
- **FURTHER RESOLVED:** That the Agency Administrator or his or her designee as agent of the Agency is hereby authorized to negotiate and enter into an agreement with Oak Center Cultural Center, Inc., in an amount not to exceed \$50,000 to make improvements to the Oak Center Cultural Center; and be it
- **FURTHER RESOLVED:** That the Agency Administrator or his or her designee as agent of the Agency is hereby authorized to negotiate and enter into an appropriate amendment to the Repayment Agreement with the City to provide for the Agency funding of City improvements; and be it

FURTHER RESOLVED: That all agreements shall be reviewed and approved as to form and legality by Agency Counsel and shall be filed with the Agency Secretary; and be it

**FURTHER RESOLVED:** That the Agency Administrator or his or her designee is hereby authorized to take whatever other action is necessary with respect to the funding and the project consistent with this Resolution and its basic purposes.
