RESOLUTION NO. 88797 C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 88793 C.M.S., WHICH, AMONG OTHER THINGS, ADOPTED THE FISCAL YEAR 2021-22 WORKFORCE DEVELOPMENT BUDGET AND AUTHORIZED GRANT AWARDS TO PROVIDERS, TO AUTHORIZE A GRANT AWARD TO THE SPANISH SPEAKING UNITY COUNCIL OF ALAMEDA COUNTY, INC. IN THE AMOUNT OF \$175,000, AND A GRANT AWARD INCREASE OF \$25,000 TO THE OAKLAND PRIVATE INDUSTRY COUNCIL, INC.

WHEREAS, the Oakland Workforce Development Board (“OWDB”) is mandated to set the OWDB budget and to oversee the expenditure of the Workforce Innovation and Opportunity Act of 2014 (“WIOA”) funding in partnership with the Mayor as local chief elected official in a designated workforce development area such as the City of Oakland; and

WHEREAS, the OWDB budget is made up of multiple funding streams that support the workforce development work; and

WHEREAS, the Oakland City Council adopted Council Resolution No. 88793 C.M.S. on July 26, 2021, which, among other things, adopted the Fiscal Year 2021-22 Workforce Development Budget and authorized grant awards to service providers selected through a competitive request for proposals process, which, among other service providers, included the Spanish Speaking Unity Council of Alameda County (the “Unity Council”), and the Oakland Private Industry Council, Inc. (“OPIC”), for the provision of employment and training services to adults, dislocated workers, youth with WIOA Title I formula funds and other funds received by the OWDB and the City; and

WHEREAS, at its July 26, 2021, Council meeting the Oakland City Council also authorized a general fund grant award to the Unity Council, in the amount of \$175,000 and increased the general fund grant award to the OPIC by an additional \$25,000, for an award of \$260,000; and

WHEREAS, the Oakland City Council desires to amend Council Resolution No. 88793 C.M.S. adopted on July 26, 2021, to award \$175,000 of general funds to the Unity Council and to increase the prior general funds grant award to the OPIC by an additional \$25,000, for an award of \$260,000; and

WHEREAS, any funds authorized by the City Council under this Resolution but not previously approved by the OWDB will be submitted to the OWDB for allocation and approval at its next meeting; now, therefore, be it

RESOLVED: That Oakland City Council Resolution No. 88793 C.M.S. is hereby amended to reflect the award of general funds to the Unity Council in the amount of \$175,000, and to award additional general funds to OPIC in the amount of \$25,000, for an award of \$260,000; and be it

FURTHER RESOLVED: That any funds authorized by the City Council Under this Resolution but not previously approved by the OWDB shall be submitted to the OWDB for allocation and approval at its next meeting.


