RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE A GRANT AWARD IN THE AMOUNT OF THIRTY-EIGHT THOUSAND DOLLARS (\$38,000) FROM THE CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL (ABC) OFFICE OF TRAFFIC SAFETY (OTS), FOR FISCAL YEAR 2024-2025 FOR THE IMPLEMENTATION OF THE OAKLAND POLICE DEPARTMENT'S ABC-OTS GRANT PROGRAM, AND AUTHORIZING THE CITY'S GENERAL PURPOSE FUND TO CONTRIBUTE FOUR THOUSAND NINE HUNDRED SIXTY THREE DOLLARS (\$4,963) TO COVER ASSOCIATED CENTRAL SERVICES OVERHEAD COSTS.

WHEREAS, it is anticipated that grant funds in an amount not to exceed thirty-eight thousand dollars (\$38,000) will be received from the State of California, Department of Alcoholic Beverage Control (ABC), Office Of Traffic Safety (OTS) for the fiscal year of 2024-2024 implementation of the ABC-OTS Grant within the Police Department; and

WHEREAS, these State of California grant funds are to be used to expand law enforcement efforts to address alcohol-related problems through a comprehensive alcohol beverage control program within the City of Oakland; and

WHEREAS, the Police Department's primary goals through the ABC-OTS grant is to reduce the illegal sales and possession of alcoholic beverages to minors, prevent and reduce the incidents of loitering at alcoholic beverage establishments, educate and conduct Informed Merchants Preventing Alcohol-related Crime Tendencies (IMPACT) inspections and increase; and

WHEREAS, the ABC-OTS Grant period of performance is from October 1, 2024 through August 31, 2025; and

WHEREAS, grant funds will be used to cover overtime costs for ABAT's enforcement operations and operational expenses related to the enforcement, outreach, and education activities; and

WHEREAS, the 13.06 percent Central Service Overhead Costs in the amount of \$4,963 is not allowed by the grantor; now, therefore be it

RESOLVED: That the City Council does hereby authorize the City Administrator to accept and appropriate a grant award in the amount not to exceed thirty-eight thousand (\$38,000) from the State of California, Department of Alcoholic Beverage Control Office Of Traffic Safety Grant; and be it

FURTHER RESOLVED: That the grant revenues from the State of California, Department of Alcoholic Beverage Control, Office Of Traffic Safety, will be allocated to the State of California Fund (2159); Special Operations Division Org (107710); Project (TBD); Special Operations Program (TBD); and be it

FURTHER RESOLVED: That the City Council authorizes a contribution of \$4,963 from the general purpose fund to cover the associated Central Services Overhead costs of 13.06 percent which the grant does not cover; and be it

FUTHER RESOLVED: That all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copies shall be placed on file in the City Clerk's Office; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to complete all required negotiations, certifications, assurances and documentation required to accept, modify, extend and/or amend the agreement.
