RESOLUTION AUTHORIZING AWARD OF A CONSTRUCTION CONTRACT TO

AJW CONSTRUCTION FOR CITYWIDE SIDEWALK REPAIR IN THE

AMOUNT OF \$1,910,036.50 (CITY PROJECT NO. G212730)

SUMMARY

Council is requested to approve a resolution authorizing the City Administrator to enter into a construction contract with AJW Construction for the Citywide Sidewalk Repair Project (G212730) in the amount of \$1,910,036.50. This project is funded by a federal grant (federal project number STPL-5012 (062)) that requires local agencies to use Department of Transportation guidelines for project administration and auditing.

This project will repair approximately 860 tree damaged sidewalk locations on Federal Aid Urban (FAU) streets, the major streets throughout the City. The list of locations is shown in *Attachment A*. This project is located in <u>all</u> Council Districts.

The Citywide Sidewalk Repair Project meets the following Mayor/Council Goal and Citywide Objective:

• Build Community and Foster Livable Neighborhoods — Provide for clean well maintained and accessible streets, sidewalks, facilities, amenities, parks, recreational facilities, and trees.

It is recommended that this resolution be approved.

FISCAL IMPACT

Approval of this resolution will authorize a construction contract in an amount of \$1,910,036.50. The engineer's estimate for this project was \$1,937,299.00. This project is funded with a federal grant for sidewalk repair (STPL 5012-062) and requires 11.47% local match funds. Funds were budgeted for this purpose and are available in the following projects, listed on the next page:

Funds for Contract Compliance (3%) will be set aside upon award of the contract. The 1.5% for public art is not eligible as part of this grant.

BACKGROUND

This project will repair approximately 860 tree related damaged sidewalk locations (167,000 square feet) throughout the City. As part of the grant requirement, the locations must be on FAU streets, the major streets throughout the City of Oakland. The work will also include approximately 9,000 square feet of driveway repair, 2,700 linear feet of curb repair, 7,000 square feet of gutter repair, and construction of 25 new curb ramps. The locations were selected from the existing backlog of repairs. The repairs will reduce the current backlog by approximately 5%.

On June 27, 2005, the City Clerk received two bids for the subject project:

- 1. AJW Construction \$1,910,036.50
- 2. Golden Bay Construction, Inc. \$2,022,570.67

Department of Transportation guidelines are used to administer this project. There will be Disadvantaged Business Enterprise (DBE) participation of \$1,670,036.50 (87%), which exceeds the project's goal of 0%. The DBE goal is set annually for the City of Oakland. The goal is not project specific, but instead an overall goal is set for all of the projects within the City of Oakland. Once the City's overall goal is reached, the DBE goals for the remaining projects are 0%. The City's overall goal for fiscal year 2004-05 was 8.2%. The DBE information has been verified by the Contract Compliance Division of the City Administrator's Office and is shown on Attachment B.

KEY ISSUES AND IMPACTS

The work is scheduled to begin in October 2005. The contract has a total duration of 260 working days. Liquidated damages of \$500 per calendar day in excess of the 260 working days specified shall be assessed to the contractor. The project schedule is shown in *Attachment C*.

SUSTAINABLE OPPORTUNITIES

<u>Economic</u>: All public works contracts require payment of prevailing wages. Prevailing wages offer a livable wage rate for workers and can contribute to an increased quality of life. The funds from this project should turn over in the community and help to stimulate the economic base. While not required under the DBE program, the contractor is a local contractor.

<u>Environmental</u>: The contractor will be recycling the concrete and asphalt removed, to the extent possible, during the project. Tree roots that are pruned and trees that are removed will be taken to a green waste-recycling center.

<u>Social Equity:</u> The sidewalk repair locations have been selected from the major streets throughout the City of Oakland. Reconstructed sidewalk should have a positive impact on the respective neighborhoods.

DISABILITY AND SENIOR CITIZEN ACCESS

Sidewalk repairs will improve access for all Oakland residents by removing tripping hazards and other obstacles along pedestrian pathways.

The sidewalk repair work will also facilitate and improve accessibility for persons with disabilities and senior citizens and will comply with the Americans with Disabilities Act (ADA). This project will also eliminate hazards for persons with vision disabilities and for persons with mobility impairments.

RECOMMENDATION AND RATIONALE

It is recommended that the City Administrator be authorized to enter into a construction contract with AJW Construction for the Citywide sidewalk repair project (G212730) in the amount of \$1,910,036.50. AJW Construction has met the DBE requirements, and there are sufficient funds in the project accounts.

ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the City Council approve the resolution.


