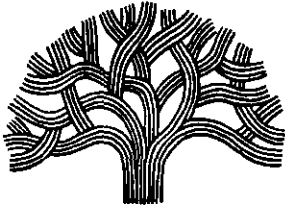

3. Three most important things for the Committee to achieve in 1997:

With the implementation period of Measure K funding scheduled to commence in January of the 1998 program year, it is essential that the Planning and Oversight Committee proceed as quickly and efficiently as possible to establish itself and its priorities.

A clear and comprehensive statement of vision and outcomes, reflecting the aspirations and realities of our community as well as the intent of the ballot initiative, would seem to me to be the very first order of business. An important component of this statement would need to be a declaration of assessed needs in our community. This document, crafted with the tools and skills brought to the Committee by its hopefully diverse membership, would consequently serve as its guidepost through the year.

Strategic guidelines delineating the manner in which the principles of this mission statement might be realized would need to be established. These would include ways in which the entire Oakland community, including our young people, would be encouraged to participate in developing and supporting programs that make a real difference in our children's lives. The guidelines would necessarily reflect the high regard and level of concern we all hold for the lives and future of our children (insistence upon effective programs of quality with consistent and measurable outcomes, culturally-appropriate availability and implementation of services, incorporation of young people in the process, etc.) as well as clear operating standards (coordination of services with communication among service providers emphasized, encouragement of collaboration between private and public agencies, efficient and accountable funding management, regular program evaluations, etc.).

Before the first Oakland Children's Fund dollar is allocated early next year, the Committee must have in place the strongest possible mechanism for evaluating resources availability, needs assessment, programs accountability and most importantly, clearly measurable outcomes.
