Pursuant to §401 of the Charter, and the action of the Council at its April 20. 2004 closed session, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action in the sum of Nineteen Thousand Nine Hundred Dollars (\$19,900.00), payable to Lenard Miller, Belinda Miller and their attorney, Wayne Johnson, Esq.

This action arises out of the arrests of Belinda and Lenard Miller on July 4, 1999. They contend they were falsely arrested and that the officers used excessive force against them. The officers deny their allegations. This settlement is recommended as a compromise of this matter and to avoid a potentially adverse jury verdict should the matter be tried.
