**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH THE YOUTH VENTURES JOINT POWERS AUTHORITY (YVJPA), THROUGH ITS FISCAL SPONSOR PHILANTHROPIC VENTURES FOUNDATION, IN THE AMOUNT OF \$150,000 PER YEAR FOR FISCAL YEARS 2025-26 AND 2026-27, FOR THE CITY OF OAKLAND'S ANNUAL CONTRIBUTIONS TO THE YVJPA**

**WHEREAS**, in 2006, the County of Alameda County, the City of Oakland, and the Oakland Unified School District formed a joint public entity named the Youth Ventures Joint Powers Authority ("YVJPA") with the goal of enhancing their collective efforts to improve outcomes for youth and their families; and

**WHEREAS**, in 2016, First 5 Alameda County, the Peralta Community College District, and the Alameda County Office of Education were added to the YVJPA; and

**WHEREAS**, as a Charter member, the City of Oakland must contribute \$150,000 annually in membership dues to the YVJPA; and

**WHEREAS**, in December 2020, the YVJPA approved a resolution to establish a partnership with the Oakland Thrives Leadership Council ("OTLC") specifying that the OTLC would serve as the YVJPA's lead organizational structure to achieve its mission to improve outcomes for children, youth and families in Oakland, and which approved the use of membership dues to support the backbone functions of the OTLC; and

**WHEREAS**, in February 2024, the YVJPA entered into a fiscal sponsorship agreement with the Philanthropic Ventures Foundation; and

**WHEREAS**, funds totaling \$300,000 (\$150,000 for each fiscal year) are budgeted and available for Fiscal Years ("FY") 2025-2027 within the General Purpose Fund (1010), Department of Human Services-Administration Organization (78111), JPA Youth Activities Project (1005959), and Childhood & Youth Services Program (YS03) for the annual contributions; now, therefore, be it

**RESOLVED:** That the City Council hereby authorizes the City Administrator to enter into an agreement with the Youth Ventures Joint Powers Authority, through its fiscal sponsor Philanthropic Ventures Foundation, in the amount of \$150,000 each year for FY 2025-2026 and FY 2026-2027 for the City of Oakland's annual contributions to the YVJPA.


