RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF PAUL SANDHU, MANOJ TRIPATHI,, KYUNG SON and WILLIAM JETTER v. CITY OF OAKLAN, ALAMEDA COUNTY SUPERIOR COURT CASE NO. RG10-544928, IN THE AMOUNT OF \$60,000.00 (PUBLIC WORKS AGENCY – INVERSE CONDEMNATION)

WHEREAS: Residential and commercial units at 311 Oak Street, owned by Plaintiffs Paul Sandhu, Manoj Tripathi, Kyung Son and William Jetter were damaged by the intrusion of water from an overflowing drainage inlet on October 19, 2009; and

WHEREAS: Plaintiffs Paul Sandhu, Manoj Tripathi, Kyung Son and William Jetter filed the above-referenced action to recover damages to their properties at 311 Oak Street; and

WHEREAS: The City has determined to compromise and settle Plaintiffs' claims aganst it for the sum of Sixty Thousand Dollars and no Cents (\$60,000.00);

NOW, THEREFORE, BE IT RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Paul Sandhu, Manoj Tripathi, Kyung Son and William Jetter v. City of Oakland, Alameda County Superior Court Bi, RG10544928, City Attorney's File No. 27570 for a sum not to exceed Sixty Thousand Dollars and no Cents (\$60,000.00), payable by the City of Oakland.


FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it
