

NOTICE AND DIGEST

ORDINANCE AMENDING OAKLAND MUNICIPAL CODE CHAPTER 12.60 TO REPEAL THE CITY'S REQUIREMENTS ON BICYCLE REGISTRATION AND LICENSING, THE REPORTING OF BICYCLE OWNERSHIP TRANSERS AND SALES, AND THE PROHIBITION ON DESROYING BICYCLE NUMBERS OR LICENSES

This ordinance repeals provisions of the Oakland Municipal Code that require the registration and licensing of bicycles, the reporting of bicycle ownership transfers and sales, and prohibiting the destruction of bicycle numbers or licenses.
