RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF LAVERNE MAINER v. CITY OF OAKLAND, et al., SUPERIOR COURT, COUNTY OF ALAMEDA, CASE NO. RG04152626, IN THE AMOUNT OF \$15,000.00 AS A RESULT OF A TRIP AND FALL ACCIDENT IN THE VICINITY OF SAN LEANDRO STREET NEAR 71ST AVENUE, OAKLAND, AUGUST 15, 2003 (PUBLIC WORKS AGENCY – TRIP AND FALL ACCIDENT)

WHEREAS, on April 26, 2004, Laverne Mainer filed a lawsuit alleging, *inter alia*, that she tripped and fell after stepping in a hole in a driveway crossing the sidewalk on San Leandro Street, where a streetlight was allegedly out of service, causing her to sustain personal injuries and medical expenses; and

WHEREAS, on September 19, 2006, Laverne Mainer agreed to accept the amount of Fifteen Thousand Dollars and No Cents (\$15,000.00), conditioned on the City obtaining a court order determining the settlement to be in good faith and barring all claims for equitable indemnity and contribution (per Code of Civil Procedure section 877.6), subject to Oakland City Council approval, as full settlement of her claims against the City in this referenced action; and

WHEREAS, on October 17, 2006, the Superior Court issued an order finding the settlement to be in good faith; it is

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Lavern Mainer v. City of Oakland, et al., City Attorney's File No. 23617, for the sum of Fifteen Thousand Dollars and No Cents (\$15,000.00); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it
