WHEREAS, On June 8, 2006 the City Council authorized \$250,000 in Priority Project Funds apiece for each Councilmember to use for district projects at each councilmember's discretion but subject to City Council approval, and as of July 1, 2007, Councilmember Priority Project fund balances from Fiscal Year Budget 2006-2007 were rolled into the 2007-2008; and

WHEREAS, The All Star Team of the Oakland, California Babe Ruth League, a 501(C)3 organization, targets 14 and 15 year old at-risk youth from throughout Oakland, and provides them with a quality athletic program that emphasizes the importance of a college education and community service; and

WHEREAS, The All Star Team combines travel baseball with the promise to introduce inner-city youth to life on various college and university campuses; and

WHEREAS, The All Star Team will make a campus tour of Morehouse College and Florida A& M University in the Fall of 2008 to become familiar with the academic, athletic and social aspects of these institutions of higher learning; and to participate in the Disney Wide World of Sports Tournament in Orlando, Florida, now, therefore, be it

RESOLVED: That the City Council authorizes a grant of fifteen thousand dollars (\$1,500.00) from Councilmember Pat Kernighan's Priority Project Funds to the Oakland, California Babe Ruth League to be used for expenses associated with two members of its All Star Team participating in the Fall 2008 College Tour; and be it
