This action arises out of a trip and fall accident on the sidewalk along 82<sup>nd</sup> Ave that borders 8140 Iris Street on July 31, 2009 which, it is alleged, was caused by a dangerous condition of public property. Settlement of this matter is recommended to avoid the risk of a more adverse jury verdict. This matter was heard in closed session on October 18, 2011.
