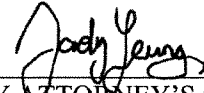

**RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF
KAITILIN KUSHNER, AND THE APPOINTMENT OF MARIO HERNANDEZ,
NIA JACOBS, SABINA KARIAT, AND SARITA SCHREIBER AS MEMBERS OF
THE PUBLIC ART ADVISORY COMMITTEE**

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 11086 C.M.S., amended by Ordinance No. 13562 C.M.S., establishes the Public Art Advisory Committee as a professionally qualified citizen committee responsible for advising the City regarding its public art program; and

WHEREAS, the Public Art Advisory Committee consists of nine members serving three-year terms with no more than two consecutive terms; and

WHEREAS, the Honorable Mayor Barbara Lee has reappointed Kaitlin Kushner, and the appointments of Mario Hernandez, Nia Jacobs, Sabina Kariat, and Sarita Schreiber to serve three-year terms on the Public Art Advisory Committee subject to confirmation of the City Council; now, therefore, be it

RESOLVED: That the City Council hereby confirms the Mayor's appointment of the following individuals to the Public Art Advisory Committee as set forth below:

Kaitlin Kushner, to serve a second three-year term on the Public Art Advisory Committee, beginning October 1, 2025, and ending September 30, 2028.

Mario Hernandez, to serve a three-year term on the Public Art Advisory Committee, beginning October 1, 2025, and ending September 30, 2028.

Nia Jacobs, to serve a three-year term on the Public Art Advisory Committee, beginning October 1, 2025, and ending September 30, 2028.

Sabina Kariat, to serve a three-year term on the Public Art Advisory Committee, beginning October 1, 2025, and ending September 30, 2028.

Sarita Schreiber, to serve a three-year term on the Public Art Advisory Committee, beginning October 1, 2025, and ending September 30, 2028.

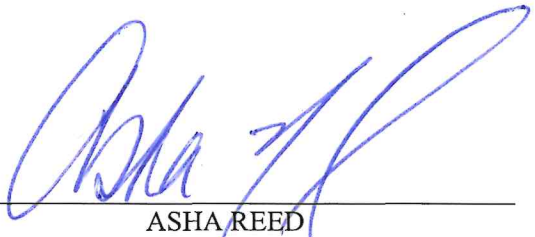
