### RESOLUTION APPOINTING LISA RASLER AS THE CITY OF OAKLAND'S TRUSTEE TO THE ALAMEDA COUNTY MOSQUITO ABATEMENT DISTRICT BOARD

**WHEREAS**, the Alameda County Mosquito Abatement District was formed in 1930 pursuant to the Mosquito Abatement Districts Act authorizing formation of mosquito control districts in the State of California; and

**WHEREAS**, the California Health and Safety Code governs the creation of mosquito abatement districts; and Sections 2021 and 2024 of the California Health and Safety Code stipulate that a city council may appoint one person as a trustee to its district for a two or four-year term, respectively; and

**WHEREAS**, City of Oakland's trustee Dr. Jan Washburn's passed away and our condolences are with her family and loved ones, we are so grateful for her service to the City of Oakland and to Alameda County; and

**WHEREAS**, Dr. Washburn's seat is currently vacant, and the City Council must appoint another trustee to complete Dr. Washburn's term which began January 1, 2022, and ends on December 31, 2025; and

**WHEREAS**, community member Lisa Rasler has graciously agreed to join the Board and complete the term previously held by Dr. Washburn; and

**WHEREAS**, the City Council's Rules of Procedure (Resolution No. 90066 C.M.S.) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore, be it

**RESOLVED:** That Lisa Rasler, an Oakland resident, is hereby appointed as a Trustee of the Alameda County Mosquito Abatement District Board to complete the term previously held by the late Jan Washburn, effective immediately for the remainder of the four-year term ending December 31, 2025.


