**RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT AND APPROPRIATE UP TO TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) FROM THE U.S. DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE, FOR THE POLICE DEPARTMENT'S PROJECT EXILE INITIATIVE**

**WHEREAS**, the U.S. Department of Justice, Bureau of Justice Assistance has advised that the City of Oakland has been awarded a grant in an amount not to exceed two hundred fifty thousand dollars (\$250,000) to support the Oakland Police Department's Project Exile initiative; and

**WHEREAS**, Project Exile is designed to reduce the supply of guns, provide increased enforcement in relationship to the apprehension of illegal gun dealers, and provide prosecution options which allow for enhanced sentencing penalties for illegal gun use within the City of Oakland; and

**WHEREAS**, funding for Project Exile is provided in direct relationship to the U.S. Department of Justice, Bureau of Justice Assistance's Reducing Community Gun Violence Initiative: Project Safe Neighborhoods; and

**WHEREAS**, these funds will be used to support the Police Department's efforts towards reducing gun violence within the City of Oakland; now, therefore be it

**RESOLVED:** That the City Council hereby authorizes the City Manager or his designee to accept and appropriate up to two hundred fifty thousand dollars (\$250,000) from the U.S. Department of Justice, Bureau of Justice Assistance, to the Oakland Police Department, and to complete all required negotiations, certifications, assurances and documentation required to accept, modify, extend and/or amend the grant; and be it

**FURTHER RESOLVED:** That said grant shall be maintained in the Federal Grant Fund: 2111; Org.: 101111; in a Project Account to be determined.
