**RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES CONTRACT WITH JANE E. JAMES (DBA: CAPTIONING AGENCY PROFESSIONALS), FOR REAL TIME CLOSED CAPTIONING STENOGRAPHY SERVICES FOR THE CONCURRENT REDEVELOPMENT AGENCY/OAKLAND CITY COUNCIL AND COMMITTEE MEETINGS IN AN AMOUNT OF \$210,000 FOR THE PERIOD THROUGH JUNE 30,2002**

**WHEREAS**, the City of Oakland entered into an agreement with CAPtioning Agency Professionals as of September 1999 to provide closed captioning services for City Council meetings during the period of September 16, 1999 through January 29,2001; and

**WHEREAS**, the Agreement was entered into due to the requirements of the Americans with Disabilities Act ADA) 42 U.S.C. § 12101 et seq, and Administrative Instruction No. 123, the City's Access Policy; and

**WHEREAS**, the City of Oakland desires that Jane E. James (DBA: CAPtioning Agency Professionals) continue to provide the required services to the City of Oakland during City Council, Committee/Council meetings and all special meetings of the City Council; and

**WHEREAS**, the services to be performed under this contract are professional and specialized in nature and the calling for bids is not required pursuant to Oakland Municipal Code section 2.041.050 11; and

**WHEREAS**, the Funds for this contract thru June 30,2001 in the amount of \$60,000 shall be paid from Fund 101, Subfund 00, Account Number 54919 and Cost Center 15126; and

**WHEREAS**, the Office of the City Clerk has submitted as part of the 01-03 proposed Budget, additional funding in the amount of \$150,000 per year for this purpose; now, therefore, be it

**RESOLVED:** That the City Manager is authorized to negotiate and execute an agreement between Jane E James (DBA: CAPtioning Agency Professionals) and the City of Oakland for the period thru June 30, 2002; and be it

**FURTHER RESOLVED:** That the City Attorney shall review and approve as to form and legality all documentation with respect to this agreement.
