Resolution Appropriating \$195,019 In Interest Income Earned To The Oakland Fund For Children And Youth; And Authorizing The City Administrator To Negotiate And Execute Grant Agreements Between The City Of Oakland And Various Non-Profit And Public Agencies To Provide Direct Services For Children And Youth For Fiscal Year 2009-2010 In An Amount Not To Exceed \$13,710,005; And Authorizing The City Administrator To Change The Not To Exceed Amount To The Total Of \$11,698,739, If The Voters Approve A Kids

First! Charter Amendment In The Special Election On July 21, 2009

SUMMARY

The Oakland Fund for Children and Youth (OFCY) Planning and Oversight Committee (POC) requests that City Council approve and authorize the execution of grant agreements for 137 continuing programs during FY 09-10. The 137 programs are expected to provide direct services to thousands of children and youth throughout Oakland through early childhood programs, after-school and summer programs, and youth development programs that build leadership and career and college readiness.

Under Article XIII of the City Charter establishing the Kids First! Children's Fund, and amended through the passage of Measure OO in November 2008, funds are set aside for City administration and OFCY grant-making for direct services for children and youth through programs provided by non-profits and public agencies. A charter amendment on the July 21st Special Election ballot, placed on the ballot by the Oakland City Council, will modify the formula for the revenue appropriations set-aside for Kids First! beginning in FY 09-10 if approved by the voters.

Measure OO provides that the appropriation for OFCY grants for FY 08-09 will be renewed for FY 09-10. In light of both Measure OO and the City Council's action to place a charter amendment on the ballot to amend OO, the Planning and Oversight Committee approved a two-fold motion. The POC approved the renewal of the grants at 100% of the current funding level in accordance with Measure OO, in the amount of \$13,710,005 for the 137 continuing grants. The POC approved the renewal of the non-summer grants at a reduced funding level if the charter

amendment is approved by Oakland voters. Summer programs are to be funded at 100% since these programs will be contracted and concluded prior to the vote count.

The accompanying resolution authorizes the City Administrator to: (1) Renew FY 08-09 grant agreements at their current funding level in accord with Measure OO, and (2) Execute the grant agreements at the reduced funding level (with the exception of summer programs) if the Kids First! charter amendment is approved by the voters.

The resolution attached to this staff report appropriates interest income of \$195,019 earned from March 1 to February 28, 2009, to the Kids First! Children's Fund (Fund 1780). Funds available for the renewal of grants include 90% of the interest earned appropriated (\$175,517), and \$1,484,509 from the available unspent project balance (carry forward) in Fund 1780. These funds will use for FY 09-10 grants if Article XIII of the Oakland Municipal Charter is amended.

Under Article XIII of the City Charter as amended by Measure OO, the projected revenues for Kids First! funds are \$15,316,500 million. An amount in excess of \$13.7 million is available for grants in FY 09-10 under the annual revenue set aside formula established under Measure OO.

If the proposed charter amendment passes, Kids First! revenues of \$11,377,679 are projected using the annual revenue set aside formula of 3% of unrestricted general purpose funds, and an estimated \$10,234,911 is available for grants. The total of Kids First! funds made available for grants will also include interest earnings to Kids First!, and unspent carryforward funds from prior years identified in Fund 1780.

A complete list of programs recommended for renewal is included as *Attachment A* in the amount of \$13.7 million at 100% of current grant levels (except for school closures), and in the amount of \$11,698,739 if the charter amendment is approved. If Article XIII is amended, FY09/10 OFCY grants would be continued but reduced by 16%, except summer based grants renewed in full as approved by the POC.

FISCAL IMPACT

The attached resolution authorizes the City Administrator to execute grant agreements in the amount not to exceed \$13.7 million for 137 contracts. Funds are available in the Projected Budget PSB Kids First! Children's Fund (1780) Contracts P364030 in the amount of \$13,784,850.

If the charter amendment on the Special Election ballot of July 21, 2009 is approved by the voters, the resolution will authorize the City Administrator to execute grant agreements in reduced amounts (except for summer programs in full amounts) for OFCY services not to exceed \$11,698,739.

Item: _____ Life Enrichment Committee May 26, 2009 Funds totaling \$11,894,937 are available for the proposed grants from the projected FY 09-10 Kids First! annual revenues, the appropriation of interest earned to the Fund 1780, and unspent project carry forward balances located at Kids First! Oakland Children's Fund (1780). The amount available for grants from annual revenues would be a reduced amount of \$10,234,911 based on current projection of annual revenue available if the charter amendment passes.

An additional amount of the interest earned by Fund 1780 during the period March 1, 2008 to February 28, 2009, \$175,517 or 90% is available for FY 08-09 grants. Ten percent of the interest earned for each year is appropriated to Kids First! Fund 1780, Department of Human Services Org. 78251, for the administration, planning and evaluation of OFCY.

The unspent project balance of \$1,484,509 currently located at Kids First! Oakland Children's Fund (1780) OFCY Contracts (P304792), is available for grants for FY 09-10.

BACKGROUND

Approved by Oakland voters in November 1996, the Measure K – Kids First! initiative amended the City Charter and led to the establishment of the Oakland Fund for Children and Youth (OFCY) to "help young people grow to become healthy, productive, and honorable adults." The OFCY process is overseen by a 19-member Planning and Oversight Committee (POC) appointed by City Council and the Mayor. A minimum of nine seats on the POC are reserved for youth.

In November 2008, Oakland voters passed Measure OO, which references the carry forward of FY 08-09 grants for an additional year of services in FY 09-10 subject to the review of grantee past performance. To comply with Measure OO, the POC reviewed the 2007-2008 past performance and interim evaluation results for each of the grantees for the first half of the 2008-2009 program year, and is forwarding its recommendations for grant renewal.

Measure OO increased Kids First! revenue through a change in funding formula to 1.5% of all City revenues annually for the first two years, and 2.5% of the total City revenues for each year thereafter. A charter amendment has been placed on the July 21, 2009 ballot which would change

the funding formula for Kids First! to 3% of unrestricted general purpose fund revenue and would reduce the funding available to Kids First! for FY 09-10 onward.

Grants approved by Council for FY 08-09 were awarded under the guidance of OFCY's four-year Strategic Plan (2006-2010). The selection process for the programs involved review of 196 submissions based on the Request for Proposals released in November 2007.

For FY 08-09, the City Council approved the grant awards totaling \$13,820,005 for 138 programs of direct services for children in June 2008. Over 100 of these programs were continued from the 2007-2008 programs year. The firm of Community Crime Prevention Associates completed the mid-year evaluation for 2008-2009 for all programs, and a full year evaluation report for programs that performed in 2007-2008.

KEY ISSUES AND IMPACTS

OFCY Grant Agreements and Planning in FY 09-10

Article XIII provides that the grants for FY08-09 will be renewed for FY 09-10 based on performance review, and a strategic plan for the Kids First! fund will be submitted in October 2009 for Council approval. The next OFCY Request for Proposal will be released based on the new strategic plan leading to the selection of grants for FY 10-11.

OFCY establishes grant agreements for the one year period beginning July 1, 2009. Summer programs may begin as early as June 1. Grantees report quarterly on their program activities and accomplishments. The independent evaluator presents a mid-year report based on the first two quarters of data. The current year's complete evaluation will be submitted in October 2009. The POC is currently engaged in the selection process for the independent evaluation contractor for FY 09-10.

School Closure

Three OFCY funded school-based after school grants are affected by school closures. The after school program at Whittier Elementary will not be continued due to the school's closure. The after school programs led by Spanish Speaking Citizens Foundation and the Oakland Unified School District will be discontinued or renegotiated due to school closures at Peralta Creek and Cole Middle Schools. These grants are recommended at a reduced level to allow for consideration of after school programs at the remaining schools on the affected the campuses and/or for community based programming.

Funding Amounts

The original Measure OO legislation allows for contracts recommended for FY 09-10 to be renewed at the same funding level as FY 08-09. Should the ballot measure to amend Kids First!

legislation pass on July 21, the POC voted to a) preserve funding levels at 100% for summer programs, and b) approve across the board reductions in funding by 16%.

The decision to preserve summer funding was made under the assumption that summer programs will operate under current Measure OO legislation for their entire period of service delivery.

POLICY DESCRIPTION

Under the Measure OO Charter Amendment, 1.5% of total City revenues are set aside annually in a "Children's Fund" for direct services for children and youth for two years and 2.5% annually is set aside thereafter. Measure OO also establishes a floor for non-OFCY spending on services for children and youth and ties that spending to the new base year of 2007-2008.

EVALUATION OF PAST PERFORMANCE

The POC relied upon the OFCY grant monitoring and past and interim evaluation reports by Community Crime Prevention Associates to assess grantee performance for all grantees. Grantees that reported low units of service achieved, or missed the target for contracted services delivered as of the second quarter of reporting, were reviewed for progress during the third quarter. For this group, units of service appear to be low during the second quarter due to the timing of the start of the school year. School based programs begin in the fall, coinciding with OFCY's second quarter reporting. During the third quarter, all of the grantees in this group reached the appropriate level of service.

The evaluation documents performance using five performance indicators. All grantees receive site visits and participate in data collection activities including quarterly meetings and reports throughout the year. Performance targets address the percentage (%) of contracted services delivered, satisfaction ratings and changes in children's developmental assets indicated by survey responses by children, parents and staff. Additionally, the Service Performance Index (SPI) is a composite score that considers the performance results, as well as the program's cost effectiveness, and approach to programming as learned through site visit documentation.

Attachment B is a table presenting the performance indicators for the programs in each area. All of the programs are performing within the range of satisfactory performance or better.

OFCY's early childhood programs score well on the SPI score, in parent satisfaction, and parent ratings of child development in assets as a result of the program. Eight of the ten early childhood grantees continued from the FY 07-08 grant period. Nine of the fifteen summer enrichment programs continued from the 2007-2008 grant period. Summer programs consistently do well on the SPI, exceed the units of services proposed, receive very high parent and student satisfaction ratings, and report growth in youth development assets due to summer programs.

Eight out of thirteen physical and behavioral health programs continued from 2007-2008. These programs score consistently well using the SPI, with the exception of a few programs that experienced variations due to cost factors relating to the type of program, intensity of services, and target population. Low units of service achieved at the mid-year point were explained for school based programs, which may attain full service levels in the third quarter.

Of OFCY's current older youth programs, 12 of the 20 were continued from the 2007-2008 year. Two of the new programs had low SPI scores at mid-year. A few programs also missed the target for percent of contracted services, as indicated by grant monitoring reports. By the third quarter, all programs had achieved the appropriate target for contracted services. Older youth programs have lower parent satisfaction scores on average, possibly related to less parent involvement in some programs. Youth's own assessments of the changes in their development assets were lower than targeted for three programs.

In general, for 71 after school programs, OFCY's evaluation at the mid-year and from prior years finds that the composite SPI scores are improving. Some programs may show a low percentage of contracted services achieved at mid-year as programs ramp up activities by OFCY's second quarter of reporting consistent with the start of the school year. All of the programs showed a satisfactory level of services based on the updated review of third quarter OFCY data.

Most of the grantees that missed multiple targets for youth's own assessment of changes in their development assets were after school programs, mainly in middle schools. Research in the field of after school programming for middle schools, as well as reports from California the Department of Education and Oakland Unified School District Oakland SUCCESS office suggest that after school programs for this age group are challenged. The recent report on Oakland's after school programs for the Oakland SUCCESS office suggests quality improvements to help meet student needs. These include increased peer-to-peer learning opportunities, academic liaison support; and expanding training capacity of staff. Additional recommendations include stronger alignment with the school day and improved teacher and principal awareness of after school programs.

It is also noted in OUSD's evaluation report that after-school programs have demonstrated a strong influence on a student's attachment to school. Participation in the after-school programs has been associated with higher school attendance and fewer suspensions. Despite the challenges of engaging middle school and older youth, and positively demonstrating youth asset growth, all of the after school programs performed within the range of satisfactory performance and are recommended for continuation in the 2009-2010 year.

OFCY's selection process for an independent evaluation firm for FY 09-10 is currently underway. The consultant's work will involve the development of an outcome based evaluation design for each strategy area. Additionally, the implementation of the CitySpan web based data management system will increase the accountability of the OFCY grantee delivery system by enabling better tracking of proposed activities to the client participation, density, and outcomes.

SUSTAINABLE OPPORTUNITIES

Economic:

An economic opportunity is available to youth who participate in paid internships through funded programs.

Environmental:

No environmental opportunities have been identified at this time.

Social Equity:

An equity opportunity is available to increase services to immigrant children and youth, children in disadvantaged areas, and youth exposed to violence, regardless of ability to pay.

DISABILITY AND SENIOR CITIZEN ACCESS

OFCY will serve children and youth with disabilities in the FY 09-10 funding package. Of the approximately 30,000 children and youth to be served, 9% are expected to have learning disabilities; 3% to have mental disabilities, 3% to have developmental disabilities, 2% to have cognitive disabilities, and 1% to have physical disabilities.

RECOMMENDATION(S) AND RATIONALE

The POC recommends awarding OFCY grants to 137 non-profit and public agencies for a total amount not to exceed \$13,710,005 in accordance with Article XIII of the Oakland Charter and based on the revenues available under the current Kids First! revenue allocation. Secondly, the POC recommends the renewal of the same grants in reduced amounts if the proposed Kids First! charter amendment is approved by the voters on July 21, 2009. Proposals were reviewed in accordance with the Kids First! requirements and based on evaluation of past performance. *Attachment A* provides a complete list of agencies and grant amounts recommended for funding in their current amounts and reduced, subject to the outcome of the ballot measure.

Recommendations were based on the data collected in the Individual OFCY Grantee Summaries FY 2007-08 Oakland Fund for Children and Youth Final Report (Attachment D) and the OFCY Interim Briefing 2008-09 (Attachment C).

ACTION REQUESTED OF THE CITY COUNCIL

The Planning and Oversight Committee requests that City Council approve a resolution appropriating \$195,019 in interest income earned to the Kids First! Children's Fund; and authorizing the City Administrator to negotiate and execute grant agreements between the City of Oakland and various non-profit and public agencies to provide direct services for children and youth in an amount not to exceed \$13,710,005 for FY 09-10; and authorizing the City Administrator to negotiate and execute grant agreements between the City of Oakland and the same non-profit and public agencies in an amount not to exceed \$11,698,739, if the Kids First! charter amendment is approved during the Special Election on July 21, 2009.

RESOLUTION APPROPRIATING \$195,019 IN INTEREST INCOME EARNED TO THE OAKLAND FUND FOR CHILDREN AND YOUTH; AND AUTHORIZING THE CITY ADMINISTRATOR TO NEGOTIATE AND EXECUTE GRANT AGREEMENTS BETWEEN THE CITY OF OAKLAND AND VARIOUS NON-PROFIT AND PUBLIC AGENCIES TO PROVIDE DIRECT SERVICES FOR CHILDREN AND YOUTH FOR FISCAL YEAR 2009-2010 IN AN AMOUNT NOT TO EXCEED \$13,710,005; AND AUTHORIZING THE CITY ADMINISTRATOR TO CHANGE THE NOT TO EXCEED AMOUNT TO THE TOTAL OF \$11,698,739, IF THE VOTERS APPROVE A KIDS FIRST! CHARTER AMENDMENT IN THE SPECIAL ELECTION ON JULY 21, 2009

WHEREAS, approved by Oakland voters in November 1996, the Measure K –Kids First! initiative established the Oakland Fund for Children and Youth (the "Fund") under Article XIII of the Oakland Municipal Charter to help young people grow to become healthy, productive, and honorable adults and set aside 2.5% of the City's unrestricted general purpose fund revenues every year for targeted services benefiting children and youth; and

WHEREAS, in November 2008, the voters approved Measure OO, replacing Article XIII of the Oakland Municipal Charter and increasing the set aside for targeted children and youth programs to 1.5% of the City's total annual revenues for two years, beginning on July 1, 2009, and to 2.5% of the City's total yearly revenues each year thereafter; and

WHEREAS, under Measure OO, the set aside for the Fund is projected to be in excess of \$15 million for the fiscal year beginning July 1, 2009; and

WHEREAS, the City Council approved a ballot measure for the Special Election on July 21, 2009 to amend Article XIII, revise the annual revenue set aside for the Fund to 3.0% of the City's actual unrestricted general purpose fund revenues, which are projected to be \$11.3 million for FY2009/2010; and

WHEREAS, the revenue appropriation for FY2009/2010 to the Fund (Fund 1780) is to be approved in the FY2009-2011 budget process and 90% of the appropriation will be available for grants as specified in Article XIII of the City Charter; and

WHEREAS, any interest earned on the Fund and any amounts unspent or uncommitted by the Fund at the end of any fiscal year are to be made available for future grants as specified in Article XIII of the City Charter; and

WHEREAS, interest earned on the Fund from March 1, 2008 to February 28, 2009 totaled \$195,019, of which 10% (\$19,519) is available for planning, administration, and evaluation, grant-making and management, training and technical assistance, communications and outreach and 90% (\$175,517) is available for grants according to the terms of Article XIII of the City Charter; and

WHEREAS, the City Council wishes to appropriate the interest income of \$195,019, and to allocate the specified portion of said funds to 1) grants for direct services for children and youth in FY2009/2010, and to 2) planning, administration, and evaluation, according to the terms of Article XIII of the City Charter; and

WHEREAS, prior interest and revenue appropriations for services that have been completed resulted in an unspent project balance of \$1,484,509 in Kids First! Oakland Children's Fund (1780) from projects Oakland Fund for Children and Youth ("OFCY") FY2008-2009 Grants Contracts (P304490), and these funds are available for allocation to grants in FY2009/2010; and

WHEREAS, the Planning and Oversight Committee ("POC") created by the Measure K – Kids First! initiative in 1996, provides oversight and direction for the OFCY planning and funding review process; and

WHEREAS, under the Kids First! charter provisions, as amended by Measure OO, the appropriations for services for children and youth in 2008-2009 are to be continued to 2009/2010, and the grants agreements for targeted services are to be renewed as forwarded by the POC subject to performance review; and

WHEREAS, the POC has reviewed the performance of the current grantees in FY2008/2009; and

WHEREAS, the POC recommends the renewal of grant agreements for 15 summer enrichment programs and one summer youth employment program in the grant amounts contracted in FY2008/2009 in full; and

WHEREAS, the POC recommends the renewal of grant agreements for all other programs also at 100% of the grant amount contracted in FY2008/2009 in compliance with funds available under Measure OO, or in the amounts specified below if the July 2009 charter amendment is approved:
