Subject: Request to correct ordinance recorded in error



Hello Ceda --

What is the procedure to correct the version of an ordinance which has already been recorded? When the Rockridge Business Improvement District was established in Dec. 2000 Council approved it on the condition that the related ordinance be amended to include some additional language. I hand-delivered the amended ordinance from the City Attorney's office to Maria Ezcurra in the City Clerk's office on Dec. 7 for recording; however, the Clerk's office still accidentally recorded the wrong version of the ordinance (i.e. the original unamended version). How do we now correct this error? The minutes of the City Council meeting on Dec. 12, 2000 would show that the amended ordinance is the one that should have been recorded and that the one currently on record is incorrect. Referring to the ordinance language comes up so infrequently that it just recently came to my attention again that the ordinance on record is the wrong version.

I still have a copy of the amended ordinance which should have been recorded, but who should I give it to? Thank you for your help.
