C232410, C232610, B246510, C229310) FOR TRAFFIC SIGNAL INSTALLATIONS AT THREE INTERSECTIONS (INTERNATIONAL BOULEVARD AT 4TH AVENUE, INTERNATIONAL BOULEVARD AT 21ST AVENUE, AND MARTIN LUTHER KING JR. WAY AT 53RD STREET) IN THE TOTAL AMOUNT OF FIVE

HUNDRED FIFTY-ONE THOUSAND TWO HUNDRED NINETY DOLLARS

WHEREAS, there are sufficient funds for the construction contract in the State Gas Tax Fund (2211); Capital Improvement Projects – Transportation Services Organization (92246); and Council District 2 Pay-Go Project (B246510); and

WHEREAS, the City lacks the equipment and personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy or better performance; and

WHEREAS, Ray's Electric complies with all Local/Small Local Business Enterprise Program requirements; and

WHEREAS, the City Council finds and determines that services under this contract will be temporary; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

RESOLVED: That the construction contract for the CIP Traffic Signal Project (City Project No. 232410, 232610, B246510, C229310) is hereby awarded to Ray's Electric in accordance with terms of its bid, dated October 17, 2005, for the amount of five hundred fifty-one thousand two hundred ninety dollars and zero cents (\$551,290.00); and be it

FURTHER RESOLVED: That the plans and specifications prepared by the Director of the Public Works Agency for the CIP Traffic Signal Project (City Project No. C232410, C232610, B246510, C229310) are hereby approved; and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$551,290.00 (100% of Contract), and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for amount due under the Unemployment Insurance Act, \$551,290.00 (100% of Contract), with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Administrator, or her designee, is hereby authorized to enter into a contract with Ray's Electric Company on behalf of the City of Oakland and execute any amendments or modifications of said contract within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved for form and legality by the City Attorney, and a copy of the contract shall be kept on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That, the City Clerk is hereby directed to post conspicuously forthwith notice of the above award on the official bulletin board in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the approval of this resolution requires a two-thirds vote of the Council members.
