# RE: Report from the City Administrator Regarding Budgeting of Positions in the Office of the City Auditor

### SUMMARY

Due to the transfer of six employees from the City Auditor's Office to other City departments, the City Administrator's Office is seeking City Council direction for the funding of new hires in the Auditor's Office for the remainder of FY 2005-06 and FY 2006-07.

### FISCAL IMPACT

Funds will need to be identified from the General Purpose Fund to cover the staffing costs in the amount of \$69,839 in FY 2005-06 and \$405,718 in FY 2006-07. If Council chooses, the \$405,718 may be considered during the Mid-Cycle Budget Adoption process.

### **KEY ISSUES AND IMPACTS**

The funding that was initially appropriated for the Auditor's positions is currently being used to fund the existing employees in their new positions in other City departments. Additional funding is required to backfill the six (6) positions in the Office of the City Auditor. The vacancies can be filled in a two-phase approach:

### Phase I:

For the remainder of fiscal year 2005-06 (through June 30, 2006), \$69,839 in funding would be required to fill the following three (3) positions: two (2) Auditor I positions and one (1) Auditor III position

Phase 2:

For the period between July 1, 2006 through June 30, 2007, \$405,718 in funding would be required to fill six (6) positions, consisting of one (1) Receptionist, two (2) Auditor III positions, one (1) Auditor I position and two (2) Student Trainees.

### RECOMMENDATION

Submitted for your consideration, is a resolution to appropriate the \$69,839 in FY 2005-06 and a second resolution to appropriate both the \$69,839 in FY 2005-06 and \$405,718 in FY 2006-07.
