Dollars (\$353,980.00)

### **SUMMARY**

A resolution has been prepared for Council to authorize award of a construction contract to Bay Construction in the amount of \$353,980.00 for the Rehabilitation of Trestle Glen Stairs project. The project is located in Council District 2.

Bay Construction is the responsible low bidder and has met all the contract requirements.

Funds are available for the contract work. This project is consistent with the Mayor and City Council Goal to Improve Oakland's Neighborhoods and to Maintain and Enhance Oakland's Physical Assets.

The project will rehabilitate the stairs and thereby improve pedestrian safety and mobility for the community.

Staff recommends approval of the resolution.

### FISCAL IMPACTS

The Engineer's Estimate is \$338,331.00 and the low bid is \$353,980.00 provided by Bay Construction. The construction contract is in the amount of \$353,980.00, and the construction contingency is \$35,398.00 (10% of the contract amount). The project has sufficient funds to pay for the construction contract, contingency, design support, and construction management costs of the project. The City has all the existing funding of \$450,000.00 in the Rehabilitation of the Trestle Glen Stairs (Project No. C214820) Fund 2211, needed to complete this project. The source of the funding is from the Alameda County Transportation Improvement Authority (ACTIA).

#### **BACKGROUND**

The City of Oakland has approximately 272 paths and stairways. The demand is great for rehabilitating existing paths and stairways in Oakland. These paths and stairways are evaluated and prioritized based on the Council adopted prioritization criteria. These stairs have all been surveyed and ranked according to a variety of variables and assigned a numerical score. The variables include the condition of the stairs, proximity to transit and or schools, number of residents adjacent to the stairs and whether the stairs are currently useable. The Public Works Agency updates this ranking system every year and plans to conduct a more extensive survey this year.

This project is one of several planned projects to rehabilitate existing paths and stairways throughout Oakland. The Public Works Agency's annual budget for stairs repair is \$350,000 from Measure B funds. This covers roughly one project per year. The Trestle Glen stairs project was selected based on a longstanding commitment to the community.

Attachment C is the location of the two flights of stairs in the Trestle Glen neighborhood. Attachment D is the Citywide Inventory of Stairs and Paths.

On September 29, 2006, advertisement of the project to solicit bids was placed in the Oakland Tribune and San Francisco Chronicle newspapers, and Notices to Bidders were sent to all contractors holding an "A" License in the City's database and the Daily Pacific Builder.

On October 23, 2006, the City Clerk received and opened three bids for the project as shown in the table below. Bid discounts of 5% for Local Business Enterprise and Small Local Business Enterprise (SLBE/SLBE) participation were applied to these bids. Bid details are presented in the Contract Compliance memo of Attachment A. Bay Construction had both the lowest project bid as well as the lowest bid that incorporated bid discounts. Thus Bay Construction, the lowest responsible bidder, is recommended for contract award with a bid price of \$353,980.00.

Item: \_\_\_\_\_ Public Works Committee March 13, 2007 Compliance with City Programs: Bay Construction is in full compliance with City goals for Local and Small Local Business Enterprises. Under the proposed contract, Bay Construction exceeds the City's 20% LBE/SLBE requirement. The bid documents show Local Trucking participation of 100%.

#### **KEY ISSUES AND IMPACTS**

Construction is scheduled to begin in middle of March 2007 and should be completed by June 2007. The project schedule is contained in Attachment B. The contract specifies \$750.00 in liquidated damages per calendar day if the contractor exceeds the contract completion time of 55 working days.

Staff has reviewed the submitted bids for this work and determined that the lowest bid is reasonable

### PROJECT DESCRIPTION

In general, the proposed work consists of the reconstruction of an existing public stairway with timber and concrete stairs, handrails, new concrete pathway and sidewalk, fences, concrete and stone walls.

### SUSTAINABLE OPPORTUNITIES

<u>Economic</u>: Over 90% of the work is performed by Oakland residents, thus providing jobs, and improving the local economy. The project will also improve pedestrian safety and enhance the general aesthetics of community with new and improved stairs, concrete pathway and sidewalk.

<u>Environmental</u>: Air quality will be improved to the extent that the new stairs encourage pedestrian traffic and circulation in the community. The contractor will be required to make every effort to reuse clean fill materials and use recyclable concrete and asphalt products.

<u>Social Equity</u>: The stairs, handrails and pedestrian access suffered from general deterioration, which decreased the level of safety and access to pedestrians. The new and improved stairways with handrails, paved pathway and sidewalk will provide pedestrian accessibility, and safer, more livable and cleaner pedestrian areas at Trestle Glen Road, Bowles Place and Van Sicklen Place.

### DISABILITY AND SENIOR CITIZEN ACCESS

The project will construct new paved pathways, sidewalks and stairs that meet the Federal Americans with Disabilities Act. The Trestle Glen area will be more accessible and safer for all citizens, especially senior citizens and persons with disabilities.

### RECOMMENDATION AND RATIONALE

It is recommended that the construction contract be awarded to Bay Construction, the lowest responsible bidder, in an amount not to exceed \$353,980.00 for constructing the Rehabilitation of Trestle Glen Stairs (Project No. C214810).

The contractor, Bay Construction, has met the LBE/SLBE requirements and there are sufficient funds in the project account.

### ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the City Council approve the resolution.







RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO BAY CONSTRUCTION FOR THE REHABILITATION OF TRESTLE GLEN STAIRS (PROJECT NO. C214810) FOR AN AMOUNT NOT TO EXCEED THREE HUNDRED FIFTY-THREE THOUSAND NINE HUNDRED EIGHTY DOLLARS (\$353,980.00)

WHEREAS, the project consisting of construction of timber and concrete stairs, handrails, new concrete pathway and sidewalk, fences, concrete and stone walls will improve the deteriorating pedestrian pathways and accessibility, and connect these restored stairs to a network of stairs and paths leading to mass transit; and

WHEREAS, the project will reduce blight, improve and upgrade the pedestrian amenities and pedestrian safety, and meet the Federal Americans with Disabilities Act requirements; and

WHEREAS, on September 29, 2006, advertisement of the projects to solicit bids was placed in the Oakland Tribune and San Francisco Chronicle newspapers, and Notices to Bidders were sent to all contractors holding an "A" License in the City's database and the Daily Pacific Builder; and

WHEREAS, on October 23, 2006, the City Clerk received and opened three bids for these projects. Bay Construction is the responsible low bidder with a bid price of \$353,980.00 and has met the 20% City contract requirements for Local Business Enterprise and Small Local Business Enterprise (LBE/SLBE); and

WHEREAS, there are sufficient funds available in the project budget to cover the project costs including the construction contract ten (10%) percent contingency, design support and construction management costs for the project; and

**WHEREAS**, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City has all the existing funding of \$450,000.00 in the Rehabilitation of the Trestle Glen Stairs (Project No. C214820) Fund 2211, needed to complete this project with Alameda County Transportation Improvement Authority (ACTIA) as the source of funding; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds that services under this contract will be temporary; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

**RESOLVED**: That the City Administrator is authorized to award a contract to the responsible low bidder, Bay Construction, in accordance with the terms of its bid therefore, for an amount of Three Hundred Fifty-Three Thousand Nine Hundred Eighty Dollars (\$353,980.00); and be it

**FURTHER RESOLVED**: That the plans and specifications prepared by the Director of Public Works for this project are hereby approved; and be it

**FURTHER RESOLVED**: That the amount of the bond for faithful performance is one hundred percent (100%) of the bid amount, and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, equal to the bid amount, with respect to such work are hereby approved; and be it
