RE: A Supplemental Report and Resolution Authorizing a Professional Services Contract with Third Wave Consulting in an Amount not to Exceed \$36,000, for the Design, Configuration, and Implementation of a Customer Relationship Management Application of Salesforce.com to be Partially Paid for with Redevelopment Agency Funds

SUMMARY

At the November 12th CED Committee, Council requested that staff address the possibility of funding sources other than Recycling Market Development Zone (RMDZ) funds and provide an estimate of the maximum recurring, annual cost for licensing.

FISCAL IMPACT

The November 12, 2008, report recommends the use of \$20,000 in RMDZ funding. As requested by CED Committee, staff looked at alternative funding sources to support this project. Staff has identified \$10,000 from the Community Development Block Grant (CDBG) fund and reduced the contribution from the RMDZ fund by the same amount. The following chart indicates the new sources of funding if CDBG funds are utilized.

KEY ISSUES AND IMPACTS

This project places no obligation on the City to expand the number of licenses beyond the initial scope. It is anticipated, however, that the efficiency of the platform configuration will strongly support expansion. Staff will propose funding sources to support a license expansion plan as part of the upcoming 2009-2011 Budget discussions.

The action requested of the City Council is to authorize a contract with a consultant and this action will require the City to pay an annual, recurring subscription fee to Salesforce for each license. The 2008 list price for one license is \$1,500 per year although it is likely that the City would be able to negotiate a discount.

To respond to the Committee's question regarding the maximum number of licenses and annual recurring costs. There are 67 budgeted positions in the Economic Development and Redevelopment Divisions. All of these positions are not filled, and some would not need licenses. It is envisioned that the first phase licenses will be designated to staff conducting economic'development activities. The cost could range between \$13,000 and \$20,000. In the second year, the project may expand to include additional Redevelopment staff that directly interact with businesses; it is estimated that the total annual cost for second year licenses could range from \$32,000 to \$48,000. In year three, should the project expand to include remaining Redevelopment or Economic Development staff, the estimated total cost would be \$58,000 to \$70,000 annually. These costs are estimates based on a recent discussion with the City's account representative at Salesforce.

As requested at the November 12th CED Committee, staff has drafted a new resolution with funding partial from CDBG to lessen the amount spent from the RMDZ funds. If the Council directs the use of CBDG funds, this will reduce staff's retail development capabilities in non-redevelopment areas, particularly in merchant organizing and commercial corridor programming such as the Oakland Merchant Association Assistance Grant Program (MAAP), which funds merchant association activities and the Oakland Merchant Leadership Forum professional services contract.

RECOMMENDATION AND RATIONALE

Staff recommends that the City Council approves the original resolution with the RMDZ funding. Staff has verified that RMDZ funds have been used in other cases to support general economic development activities and that the proposed use of funds (\$20,000) is consistent and allowable under RMDZ Program requirements.

ALTERNATIVE RECOMMENDATION

The City Council could approve the new resolution that partially funds the contract with CDBG funds.

ACTION REQUESTED OF THE CITY COUNCIL

Staff requests that City Council either: (1) approve the original resolution with funding from RMDZ and Coliseum Redevelopment or (2) approve the new resolution with funding from RMDZ, CBDG, and Coliseum Redevelopment. Either action will authorize the City Administrator, or designee, to enter into a professional services contract in an amount not to exceed thirty-six thousand dollars (\$36,000), with Third Wave Consulting for the design, configuration, and implementation of a customer relationship management application using Salesforce.com.


