## ORDINANCE AMENDING OAKLAND MUNICIPAL CODE SECTIONS 10.48.010 "SCHEDULE OF PARKING FINES" TO INCREASE PARKING FINES

WHEREAS, the City of Oakland collects fines for violations of the Oakland Traffic Code as set forth in Title 10 of the Oakland Municipal Code; and

WHEREAS, the City of Oakland has a duty to enforce parking violations as set forth in the Oakland Municipal Code; and

WHEREAS, on May 5, 2009, the City of Oakland adopted Ordinance No. 12928 C.M.S. authorizing a \$10 "pass-through" charge on all Oakland Municipal Code and California Vehicle Code parking violation fees, to assess the State mandated amount remitted to Alameda County; and

WHEREAS, the City of Oakland seeks to raise certain fines for Oakland Municipal Code Section 10.48.010 "Schedule of Parking Fines;" and

WHEREAS, a Public Hearing was held on June 30, 2009 to review the proposed changes to these fines; now, therefore

## THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

**Section 1**. Oakland Municipal Code (O.M.C.) Section 10.48.010 "Schedule of Parking Fines" is hereby amended as set forth below. Additions are indicated by <u>underscoring</u> and deletions are indicated by <u>strike through type</u>; portions of ordinances not cited or not shown in underscoring or strike-through type are not changed.
