2) "NO PARKING ANYTIME" FROM MONDAY TO SUNDAY ON BOTH SIDES OF 37TH AVENUE BETWEEN

BOEHMER STREET AND THE SOUTHERN END

SUMMARY

A resolution has been prepared approving the establishment of 1) one-hour parking from 8:00 A.M. to 6:00 P.M., from Monday to Friday, on both sides of 37th Avenue between East 8th Street and Boehmer Street; and 2) "No Parking Anytime" from Monday to Sunday on both sides of 37th Avenue between Boehmer Street and the southern end.

California Vehicle Code section 22507 allows local authorities, by ordinance or resolution to prohibit or restrict the stopping, parking, or standing of vehicles on certain streets or highways; or portions thereof, during all or certain hours of the day.

The Oakland Municipal Code sections 10.28.180 and 10.28.250 authorize the Traffic Engineer. by Council resolution, to establish on-street parking restrictions.

FISCAL IMPACTS

The cost to install signs to indicate said limitations is approximately \$2,200.00. Funds are available in the Public Works Agency, Transportation Services Division's Neighborhood Traffic Safety Program (C371410), Measure B Fund (2211), Organization (92246). The maintenance costs will be picked up by the Citywide Sign Replacement Program (C271210), Measure B Fund (2211), Organization (92246).

BACKGROUND

37th Avenue forms a "T" intersection with Boehmer Street and is a cul-de-sac at the southern end. This segment of 37th Avenue is a mixed use neighborhood of commercial and residential properties with no posted parking restrictions.

KEY ISSUES AND IMPACTS

The Transportation Services Division (TSD) received requests from concerned merchants, residents, and the Oakland Police Department (OPD) to establish one-hour parking restriction on both sides of 37th Avenue between East 8th Street and Boehmer Street and "No Parking Anytime" from Boehmer Street to the southern end. OPD noted that this area has a constant issue with blight and nuisance from "over night" camping and littering.

Staff conducted a site evaluation taking into account parking demand, supply, and adjacent land use and found that establishing these parking restrictions does not pose an undue hardship on area residents or merchants.

Petitions were circulated to and signed by occupants of the subject blocks for the establishment of one-hour parking and "No Parking Anytime." 100% of the addresses signed the petitions.

SUSTAINABLE OPPORTUNITIES

Economic: There are no sustainable economic opportunities resulting from the proposed establishment of the one-hour parking and "No Parking Anytime" zones.

Environmental: The establishment of parking restrictions on 37th Avenue will curtail illegal activities and enhance the overall environment in the neighborhood.

Social Equity: The proposed parking restrictions will reduce blight in the neighborhood.

DISABILITY AND SENIOR CITIZEN ACCESS

The proposed parking changes are not anticipated to have an impact on disabled and senior citizen access.

RECOMMENDATION AND RATIONALE

Staff recommends adoption of the resolution establishing one-hour parking from 8:00 a.m. to 6:00 p.m., from Monday to Friday, on both sides of 37th Avenue between East 8th Street and Boehmer Street, as well as the establishment of "No Parking Anytime" from Monday to Sunday on both sides of 37th Avenue between Boehmer Street and the southern end.

Staff recommends that the City Council adopt the resolution.



WHEREAS, funds totaling \$2,200.00 are available in the Public Works Agency, Transportation Services Division's Neighborhood Traffic Safety Program (C371410), Measure B Fund (2211), Organization (92246) to install parking restriction signs; now, therefore, be it
