RE: Receive a Status Report On The Review Of Existing Contracts With Companies

Headquartered In Arizona And Opportunities To Discontinue Those Contracts

### **SUMMARY**

City Council adopted the Arizona Boycott Resolution 82727 C.M.S. on May 4, 2010. The Arizona policy became effective immediately and states in part the following:

RESOLVED: That unless and until Arizona rescinds SB 1070, the City of Oakland urges City departments:

- 1. to the extent practicable, and in instances where there is no significant additional cost to the City or conflict with law, to refrain from entering into any new or amended contracts to purchase goods or services from any company that is headquartered in Arizona;
- 2. to not send City officials or employees to conferences in Arizona, and
- 3. to review existing contracts for the purchase of goods and services with companies headquartered in Arizona and explore opportunities to discontinue those contracts consistent with the terms of those contracts and principles of fiscal responsibility, ....."

The Accounting Division of the Finance and Management Agency (FMA) staff searched Oracle and identified all Arizona addresses to which the City made payments. The Department of Contracting and Purchasing staff contacted those businesses directly or searched specific company profiles to determine if those addresses were actually the business headquarters. A list of those businesses headquartered in Arizona is provided as *Attachment C*.

#### KEY ISSUES AND IMPACT

The City Administrator directed staff to review the list of firms with Arizona headquarters and ensure that each contract comports with the Arizona Resolution 82727 C.M.S. specific to the following:

(1) Of all existing contracts and pending contracts, explore opportunities to discontinue those contracts/agreements consistent with contract terms and principles of fiscal responsibility. Contact the Department of Contracting and Purchasing for assistance.

- (2) If it is <u>not</u> feasible to discontinue certain contract/agreements, using the attached Schedule B-1 Arizona Boycott Checklist (*Attachment A*) please document why it is not feasible to do so.
- (3) Agency and department heads are considered the approving authority for Schedule B-1
- (4) Communicate to departmental staff that direct pay (per AI 1021) purchases and payments to Arizona-headquartered companies and businesses are held in abeyance until further notice:
  - a. Direct staff not to travel nor attend conferences held in Arizona.
  - b. Departmental staff with approval authority should not approve any direct pay purchases from companies and businesses in Arizona.
- (5) The Accounting Division of FMA will not process payments to companies and businesses headquartered in Arizona. Any exceptions must be accompanied by a completed Schedule B-1Arizona Boycott.
  - a. Submitted invoices issued by companies and businesses based in Arizona will be returned to departments unprocessed.
  - b. Ensure that travel requests to Arizona will not be processed.

Moving forward, DCP has prepared Schedule B-2 "Arizona Resolution Declaration of Compliance" *Attachment B*, to include in all solicitations processed through contract administration and purchasing services.

Contracts and purchase orders will not be processed without a completed Schedule B-2 from businesses or a completed Schedule B-1 approved by agency and department heads.

For 2010, Oracle data revealed 11 contracts with companies headquartered in Arizona. Of those 11 contracts:

- Oakland Police Department is the administrator of 6 contracts
- Public Works is the administrator of one contract
- Oakland Fire Department is the administrator of three contracts
- Oakland Parks & Recreation is the administrator of one contract.

For 2009, Oracle data revealed 14 contracts with companies headquartered in Arizona. Of the 14, several are the same businesses used in 2010. Of those 14 contracts:

- City Administrator is the administrator of one contract
- DHS is the administrator of one contract
- DIT is the administrator of two contracts
- FMA is the administrator of one contract
- OFD is the administrator of one contract
- OPD is the administrator of five contracts

- OPR is the administrator of two contracts
- PWA is the administrator of two contracts

Each department is in the process of determining those contracts that are economically feasible to terminate and those that are not. Staff will return to council with a status of contract activity subsequent to the decisions of each department.
