RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HIS DESIGNEE TO ENTER INTO SUB-RECIPIENT GRANT AGREEMENTS WITH REGIONAL PARTNER AGENCIES IN ORDER TO CONVEY SPECIFIED EQUIPMENT TO THEM IN CONNECTION WITH REGIONAL EMERGENCY RESPONSE PREPAREDNESS ACTIVITIES FUNDED BY FY 2004 AND FY 2005 URBAN AREA SECURITY INITIATIVE (UASI) GRANTS

WHEREAS, Resolution No. 78295 C.M.S., on January 15, 2004 and Resolution No. 79182 C.M.S., on May 11, 2005 authorized the City Administrator to Accept, Appropriate and Allocate FY 2004 and FY 2005 Urban Areas Security Initiative Grant (UASI Funds) and enter into Sub-Recipient Agreements with local governments and special districts to enhance their regional emergency preparedness and response; and

WHEREAS, the City of Oakland acted as the lead agency and fiscal agent for the FY 2004 and FY 2005 UASI grant; and

WHEREAS, the City of Oakland purchased equipment in accordance with the Urban Area Security Initiative (UASI) FY 2004 and FY 2005 Grant Spending Plans on behalf of: Alameda County Public Works Agency, East Bay Municipal Utilities District (EBMUD), Alameda County Sherriff, AC Transit, Bay Area Rapid Transit (BART), Contra Costa County, and Alameda County Fire Department with FY 2004 and FY 2005 UASI grant funds; and

WHEREAS, the City of Oakland has completed its inventory for all equipment purchased with FY 2004 UASI and FY 2005 UASI grant funds; and

WHEREAS, the Grantor requires as part of the grant guidelines and grant compliance that the lead agency fiscal agent secure Sub-Recipient grant agreements for equipment purchased for and to be conveyed to regional partners, other local governments or special districts in the Oakland Urban Area Security Initiative; now therefore be it

RESOLVED: That the City Council Authorizes the City Administrator or his designee to enter into sub-recipient grants agreements for the FY 2004 and FY 2005 UASI grants with regional partner, other local governments or special districts in order to convey specified equipment to them in connection with regional emergency response preparedness activities funded by FY 2004 and FY 2005 Urban Area Security Initiative (UASI) grants; and be it

FURTHER RESOLVED: That equipment purchased be part of the Sub-Recipient grant agreements; and be it

FURTHER RESOLVED: That all FY 2004 and FY 2005 UASI sub-recipient grant agreements executed hereunder shall be approved for form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.
