RESOLUTION AUTHORIZING A GRANT OF \$22,021.70 FROM COUNCILMEMBER IGNACIO DE LA FUENTE'S PAY-GO FUNDS TO THE ROCKRIDGE COMMUNITY PLANNING COUNCIL FOR FABRICATION AND INSTALLATION OF PUBLIC ART, KIOSK, AND SEATING AREAS IN FROG PARK AND TO WAIVE THE COMPETITIVE PROCESS REQUIREMENT.

WHEREAS, on July 17, 2007, the City Council revised the Pay-Go procedures to limit Pay-Go uses to City of Oakland infrastructure, furniture or equipment expenditures, or to grant to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, any expenditures for purposes other than City or other government infrastructure, furniture, or equipment require council approval; and

WHEREAS, Councilmember Ignacio De La Fuente wishes to grant a portion of his Pay-Go funds to the Rockridge Community Planning Council for fabrication and installation of public art, kiosk, and seating areas in FROG park; and

WHEREAS, the FROG Park Committee worked with neighborhood artists and contractors who donated a portion of the work for this project with the remaining balance to be paid for by this grant; and

WHEREAS, in conformance with City requirements, the Rockridge Community Planning Council will provide documentation for the use of the Councilmember's Pay-Go funds; now, therefore, be it

**RESOLVED**: that the City Council authorizes the grant of \$22,021.70 from Councilmember Ignacio De La Fuente's Pay-Go fund to the Rockridge Community Planning Council for fabrication and installation of public art, kiosk, and seating areas in FROG Park and waives the competitive process requirement.
