RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES CONTRACT OF \$25,000.00, FUNDED BY COUNCILMEMBER JEAN QUAN'S PAY-GO FUNDS, TO GINA DOMINGUEZ OF SNAPSHOT MOSAICS FOR THE FABRICATION AND INSTALLATION OF FIVE "WAY FINDING" CERAMIC MOSAIC SIDEWALK PANELS AND TO WAIVE THE COMPETITIVE PROCESS

WHEREAS, on July 17, 2007, the City Council revised the Pay-Go procedures to limit Pay-Go uses to City of Oakland infrastructure, furniture or equipment expenditures, or to grant to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, Councilmember Jean Quan wishes to transfer a portion of her Pay-Go funds to the relevant Budget Department account to fund Gina Dominguez of Snapshot Mosaics for the fabrication and installation of five "Way Finding" ceramic mosaic sidewalk panels; and

WHEREAS, in conformance with City requirements, Gina Dominguez of Snapshot Mosaics will provide documentation for the use of the Councilmember's Pay-Go funds;

WHEREAS, the City of Oakland finds that this contract is professional in nature and will not result in a loss of employment or salary by any person having permanent status in the competitive service, now, therefore, be it

RESOLVED, That pursuant to Oakland Municipal Code section 2.04.051.B and findings set forth in the Councilmember Quan's report accompanying this item, the City Council finds and determines that is in the best interests of the City to waive the competitive request for proposal/qualifications process for and so waives the requirement; and, be it

RESOLVED: That the City Council authorizes the City Administrator to negotiate and execute a professional services agreement with Gina Dominguez of Snapshot Mosaics in an amount not to exceed fifteen thousand dolllars (\$15,000.00) for the above purpose; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized to execute any amendments or modifications of said contract within the limitations of the project specifications; and be it;

FURTHER RESOLVED: The agreement will reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk.
