RESOLUTION HONORING AND COMMENDING KINGDOM BUILDERS CHRISTIAN FELLOWSHIP FOR THEIR 12 YEARS OF EXEMPLARY COMMUNITY ENGAGEMENT IN EAST OAKLAND

WHEREAS, Kingdom Builders Christian Fellowship was founded in 2009 by Pastor L.J. Jennings as a home bible study group, which quickly outgrew his family room; and

WHEREAS, as Kingdom Builders Christian Fellowship members grew, they secured a location in East Oakland where they began their weekly food distribution to 350 families and opened a thrift store, furniture store, and a maintenance company which employed local community members; and

WHEREAS, in 2017, Kingdom Builders Christian Fellowship launched the Dream Center, a 100-bed facility for formerly incarcerated men; and

WHEREAS, Kingdom Builders Christian Fellowship had to move locations and temporarily moved into the Roots Academy School, before securing their current location at 1431 17th Avenue which serves as their worship center, ministry and community work offices, and transitional housing; and

WHEREAS, Kingdom Builders Christian Fellowship started a 41-unit housing development currently in pre-development with another 45-unit slated for phase II; now, therefore, be it
