INTRODUCED BY COUNCIL PRESIDENT PRO TEMPORE SHENG THAO

RESOLUTION HONORING GORDON AND SUE PIPER FOR THEIR DECADES-LONG EFFORTS TO IMPROVE WILDFIRE PREVENTION IN THE CITY OF OAKLAND

WHEREAS, after losing their family home in the 1991 Oakland Firestorm, Gordon and Sue Piper dedicated the next 30 years to wildfire prevention locally, regionally, and statewide; and

WHEREAS, as chair of the Oakland Landscape Committee (formerly the North Hills Landscape Committee), Gordon Piper successfully raised hundreds of thousands of dollars to create and maintain the Firestorm Memorial Garden (1993) and the Gateway Emergency Preparedness Exhibit Center and Fire-Resistant Demonstration Garden (2003) at either entrance to the Hiller Drive in the heart of the 1991 Firestorm area; and

WHEREAS, over the years, Gordon Piper has developed a network of corporate and other volunteers, along with providers of plants and building materials, who have donated thousands of hours and thousands of dollars-worth of in-kind services that make these two gardens beautiful symbols of survivors' resiliency in the face of overwhelming disaster; and

WHEREAS, both Gordon and Sue served as members of the Community Advisory Board of the former Wildfire Prevention Assessment District: Gordon representing District 1 in 2004-2006 and Sue representing District 1 and serving as Chair from 2015-2017; and

WHEREAS, in 2014, Sue, along with Ken Benson and Dinah Benson, initiated the Oakland Firesafe Council (OFSC), an education an advocacy nonprofit serving Oakland and Alameda County; and

WHEREAS, in its first seven years, the OFSC has become a respected voice for wildfire prevention not only in the City of Oakland, but regionally and statewide; and

WHEREAS, OFSC's leadership in such programs as Oakland Community Preparedness and Response, the Savvy Homeowner webinar series, and its efforts to form an East Bay Regional Wildfire Prevention Joint Powers Authority exemplify Sue's focus on helping East Bay residents and agencies reduce the risk of wildfire; and

WHEREAS, both Sue and Gordon received the much-coveted Jefferson Award for their community service – Gordon in 2020 and Sue in 2021; and

WHEREAS, now, after 44 years of service to Oakland, Sue and Gordon are embarking on a new adventure in Oregon, where they will be closer to their children and grandchild; now, therefore, be it

RESOLVED: That the Oakland City Oakland hereby acknowledges Sue and Gordon Piper's outstanding service to Oakland, their dedication to public service, their passion and networking on behalf of the public safety of the City of Oakland; and be it

FURTHER RESOLVED: That the Oakland City Council wishes Sue and Gordon Piper well as they embark on the next phase of their lives in Oregon.
