As a health researcher and epidemiologist, I work to obtain funding, design and execute projects, report results, and implement evidence-based findings into programs and practices. My role is sometimes leader, sometimes partner, and sometimes follower. Regardless of my role, I must work with a variety of stakeholders to identify priorities, articulate problems, build evidence, and translate evidence to solutions that are feasible, acceptable, and sustainable. I have led dozens of teams on projects ranging from \$100,000 to several million. Team members need to understand each others' motivations, sensibilities, skills, and ability to contribute, be it through sponsorship, technical qualifications, ability to bring others along, or through other positive contributions. They need to feel comfortable raising difficult issues, and they need to agree upon how they will work together. It is essential that problems and solutions be defined by those who suffer the consequences of the problems and not by well-meaning outsiders. I have been told that I am a close listener who is able to simplify and articulate complex issues. I try to stay focused on the problem at hand, to assure a level playing field, and to seek solutions that are transparent and accountable. Most of my research has been funded by taxpayers, and I am sensitive to the stewardship that is rightfully expected when using public monies. I hope that by working on the SSB CAB, I could use my training and experience to advance the health and well-being of Oakland citizens through programming to improve knowledge, diet, and exercise. I believe these funds are intended for those who have fewer social resources to care for their health, lower access to healthy food, and fewer opportunities for physical activity. As such, I would try to maintain an attitude of service to those who represent these individuals. Research shows that the best solutions are design-based, and I likely would advocate for improved design whenever possible.

INTRODUCED BY MAYOR LIBBY SCHAAF

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF LISA HERRINTON AND COURTNEY JONES AS MEMBERS OF THE SUGAR-SWEETENED BEVERAGE DISTRIBUTION TAX COMMUNITY ADVISORY BOARD

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Resolution No 86161 C.M.S., approved May 3, 2016, placed a measure on the November 8, 2016 ballot to impose a tax on the distribution of sugar-sweetened beverages; and

WHEREAS, the voters of the City of Oakland adopted the Sugar-Sweetened Beverage Distribution Tax Ordinance in the November 8, 2016 general municipal election; and

WHEREAS, the Sugar-Sweetened Beverage Distribution Tax Ordinance establishes the Sugar-Sweetened Beverage Distribution Tax Community Advisory Board (the "Board") and provides that the Board shall consist of nine (9) members serving not more than two consecutive three-year terms appointed by the Mayor and confirmed by the City Council in accordance with City Charter section 601; and

WHEREAS, the Sugar-Sweetened Beverage Distribution Tax Ordinance (Oakland Municipal Code Section 4.52.080 (B)) provides that the Board shall be comprised of: At least three residents who live in areas disproportionately impacted by diseases caused by sugar consumption; two medical professionals--one medical and one dental with public health experience or who engage in whole or in part in the prevention, diagnosis, treatment or research of, or education about chronic diseases linked to the consumption of sugar; two parents of current students of Oakland Unified School District ("OUSD"); and two members of the public with experience in addressing public health issues, related to diabetes, obesity and sugary drink consumption, community-based youth food and nutrition programs, school-based food and nutrition programs, oral health or early childhood nutrition; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Lisa Herrinton and Courtney Jones to serve a three-year term subject to confirmation by the City Council; now, therefore, be it

RESOLVED: That pursuant to City Charter section 601, the City Council confirms the mayoral appointment of Lisa Herrinton to the Sugar-Sweetened Beverage Tax Community Advisory Board as a medical professional with public health experience or who engages in whole or in part in the prevention, diagnosis, treatment or research of, or education about chronic diseases linked to the consumption of sugar, to serve a three-year term beginning on June 15, 2020 and ending on June 14, 2023, filling the seat previously held by Julia Liou; and be it

FURTHER RESOLVED: That pursuant to City Charter section 601, the City Council confirms the mayoral appointment of Courtney Jones to the Sugar-Sweetened Beverage Tax Community Advisory Board as a parent of current students of OUSD, to serve a three-year term beginning on June 15, 2020 and ending on June 14, 2023, filling the seat previously held by Justin Watkins.
