This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new and delete old classifications and amend existing classification titles and salary rates. Various departments are requesting new classifications and title changes to align with operational and service delivery needs; this applies to the new Street and Sidewalk Construction and Maintenance Planner, Tree Worker, and Manager, Capital Contracts. The pay rates of several existing classifications are being adjusted to improve attraction and reterion as the departments have been unable to fill positions, reach full staffing, and provide critical services to the community: Lifeguard, PT, Water Safety Instructor, PT; Pool Manager, PT
