APPROVAL.

This report seeks approval of a resolution authorizing the City Administration to provide greater access to budget and programming records from the Oakland Police Department, Oakland Fire Department and the Department of Human Resources, and VPPSOC inclusion in the budget review process for expenditures from the Measure Y Fund. Pursuant to Measure Y (the Violence Prevention and Public Safety Act of 2004), the VPPSOC is the legislatively-mandated Committee to "review the annual audit, evaluate, inquire and review the administration, coordination and evaluations of programs and make recommendations to the Mayor and City Council for any new regulations or ordinances for the administration of the [Measure Y] programs. (See Measure Y Initiative, Section 3. Oversight, November 2004).

For the past fiscal year there has been robust discussion between the Oversight Committee, various city departments and the general public regarding timely submittal of Measure Y revenues, expenditures and programming reports. On several occasions, requested documents were not timely submitted or were difficult to decipher. In some instances, reports were simply not submitted. As a Committee, we found it increasingly difficult to perform our "oversight" obligations pursuant to the Initiative.

Notwithstanding Oakland Police, Fire and Human Services' receipt of funds through Measure Y, rarely were all three agencies simultaneously represented during our monthly Committee meetings. As a result, Committee inquiries regarding budget and program progress were left unanswered and often held over to the following monthly meeting.

During the last three VPPSOC meetings, City Administrator Dan Lindheim presented and agreed to assist to resolve the administrative and scheduling snafu. As a result, the attached Resolution is forwarded to the Public Safety Committee/Oakland City Council for review, consideration and approval. The proposed administrative adjustments will result in full participation of the VPPSOC in the budget and programming review process for expenditures from the Measure Y Fund. The requested administrative adjustments are two-fold:


- 1. Receipt of requested budget and programming reports from the Oakland Police, Fire and Human Services Agencies to ensure Oversight Committee review, input and recommendations prior to submittal to the Oakland City Council for final approval.
- 2. Active participation of OPD, OFD and DHS staff in VPPSOC monthly and "special" meetings to present and answer questions posed by Committee members.

We respectfully request the Public Safety Committee/Oakland City Council adopt the attached Resolution to facilitate active participation of the VPPSOC in the Measure Y budget and programming process.

RESOLUTION (1) DIRECT THE CITY ADMINISTRATOR TO PROVIDE THE VIOLENCE PREVENTION AND PUBLIC SAFETY OVERSIGHT COMMITTEE MORE PROMPT AND RESPONSIVE ACCESS TO FINANCIAL AND PROGRAM RECORDS FROM THE CITY'S POLICE, FIRE AND HUMAN SERVICES AGENCIES THAN PREVIOUSLY PROVIDED; AND (2) REQUIRE THAT BEFORE **MEASURE** Y AND **PROGRAMMING** BUDGET RECOMMENDATIONS ARE SUBMITTED TO THE OAKLAND CITY COUNCIL, SUCH BUDGET AND **PROGRAMMING** RECOMMENDATION SHALL BE SENT TO THE VIOLENCE PREVENTION AND PUBLIC SAFETY OVERSIGHT COMMITTEE

WHEREAS, the citizens of the City of Oakland (the City) are committed to a community-oriented approach to violence prevention in Oakland; and

WHEREAS, preventing violence and ensuring public safety requires an integrated system of social services intervention, long-term crime-prevention program, police services and fire-safety and paramedic support; and

WHEREAS, the citizens of Oakland passed the Violence Prevention and Public Safety Act of 2004 (Measure Y) that provided an estimated \$20,000,000 over a ten-year period for violence prevention programming, community policing offices and fire safety services; and

WHEREAS, the Violence Prevention and Public Safety Act specifically mandated an "Oversight Committee," charged to "...review the annual audit, evaluate, inquire and review the administration, coordination and evaluations of the programs and make recommendations to the Mayor and City Council for any new regulations or ordinances for the administration of the [Measure Y] programs...;" and

WHEREAS, The Oakland City Council desires to promote government transparency, facilitate Oversight Committee participation in the budget and program recommendation process; now, therefore, be it

RESOLVED, the City Administrator is shall provide the Violence Prevention and Public Safety Oversight Committee more prompt and responsive access to financial and program records from the City's Police, Fire and Human Services Agencies than previously provided; and be it

FURTHER RESOLVED, before Measure Y budget and programming recommendations or reports are submitted to the Oakland City Council for consideration and approval, such budget and programming recommendation shall be sent to the Violence Prevention and Public Safety Oversight Committee.
