EXECUTIVE SUMMARY

Attachment A to this report provides information on crime, crime trends, crime reduction and crime intervention activities in Oakland for the entire calendar year 2021 (January 1, 2021 through December 31, 2021).

BACKGROUND AND LEGISLATIVE HISTORY

In 2013, the Public Safety Committee requested a quarterly report from OPD on crime trends and crime reduction activities in the City of Oakland. This report is provided four times a year and updated to include the preceding three-month period (January through March; April through June; July through September and October through December).
